Apologies for Absence

1 Election of Vice Chairs for the Municipal Year 2022-2023.

Resolved that Councillor Robert Smith be elected Vice Chair of the committee for 2022-2023.

Note: Election of Neath Port Talbot CBC Vice Chair deferred to the next meeting.

2 Disclosures of Personal and Prejudicial Interests.

In accordance with the Code of Conduct adopted by both Authorities, no interests were declared.

3 Minutes.

Resolved that the Minutes of the West Glamorgan Archives Committee meeting held on 22 July 2022 be approved as a correct record.

4 Matters Arising.

The County Archivist indicated that despite changing Internet Service Providers there unfortunately remain issues with the broadband connection at Neath Mechanics Institute. This continues to prohibit access to family history websites for members of the public. He would be seeking assistance from the IT department in NPT to try and resolve the issue.

He outlined that he had received approval to advertise for the Archives Trainee post. Updates on the appointment would be given at the next meeting.

He referred to the statement made in good faith at the last meeting which stated that the archive collections would not be moved from the Civic Centre until the strongroom had environmental recordings in line with BS4971. Unfortunately this was not correct as the collections have to be in situ in order to monitor the humidity level correctly and hence no such assurance could be given.

He indicated that the additional briefing session for members had not yet been arranged. He asked for Members to submit any views or questions on what additional information they would like to receive at another session, if it was still required.

5 Report of the County Archivist.

The County Archivist presented a report which outlined the work of the Joint Archive Service during the period June - August 2022.

Use of the Service

He reported on the figures relating the use of the service via its various platforms both in person and online. The numbers using the service continue to rise slowly.

National Broadcast Archive

He outlined that work on the installation of the 'Clip Corner' at Swansea Civic Centre has been delayed until October at the request of the National Library of Wales, who are leading the project. Further updates would be given at the next meeting.

He outlined that following discussions with the National Library and further to queries raised by Members at the last meeting regarding possible 'community' screenings of footage held under the scheme, he confirmed that this would be possible in the future under a licence agreement, and outreach events could be held.

Outreach and Educational Activity

He referred to the publication of the service's annual report in June. The report can be found at <u>https://www.swansea.gov.uk/article/6226/Annual-Report-of-the-County-Archivist</u>

He also detailed the service's part in an all-Wales bid for funds from the Anti-racist Wales Culture Heritage and Sport Fund, a bid which consists of three potential workstreams.

One of these workstreams is the digitisation and web-mounting of archival material relating to Wales' links to the historic transatlantic slave trade, a potential project which had been the subject of previous discussion by the Committee.

Professional Meetings and Training

He outlined the various professional groups attended by staff during the quarter.

Relocation of the Archives

He indicated that, since the report was submitted before the postponement of this meeting, things had moved on. He outlined that the request in the report to utilise Archives reserves is no longer needed, as the feasibility study will now be fully funded by Swansea Council.

Tracey McNulty noted that the feasibility study will be match funded by Swansea Council's Place Directorate but the main funding is coming from Welsh Government's regeneration schemes. It will build on previous work carried out and will look further at the potential for a regional archives facility. On a point of correction, she pointed to a statement in the County Archivist's report and outlined that a more accurate description of the reason for this study is that the Council does not believe that the City Centre Hub would be the best location for a regional archive of this sort. This was because it would need large-scale secure storage and access to multiple collections owned by a range of bodies and this aspiration does not accord with a 'high street' location in need of regeneration and footfall drivers.

She referred to an email she circulated prior to the meeting which sought to give the Committee further background information, additional clarity and context over some of the issues raised, in particular the support from both Welsh Government and the Council for the relocation of the West Glamorgan Archive to the Community Hub.

Accessions of Archive Collections

He detailed on the archives received by the Service during the quarter.

Report of the County Archivist

West Glamorgan Archives Committee - 16 December 2022

The purpose of this report is to outline the work of the Archive Service during the period September to November 2022

1. Use of the Service

Statistics for September to November 2022

The number of members of public using the Service on-site, September to November 2022, was **534** and the total number reached by the Service on and off-site was **634**.

As will be seen from the above table, use of the Service onsite in Swansea has more than doubled since the same quarter last year, which is encouraging. Perhaps most encouraging Page 4

has been the return of school group visits to the searchroom for education sessions onsite. However, the total usage figure onsite is still only 50% of use in the same quarter in 2019.

In the archives sector, WGAS is not alone in struggling to recover its pre-2020 user base and the consensus amongst colleagues in England and Wales appears to be that family historians are the group least likely to return to use archives, given that the majority of family history resources are now available online on a subscription or pay-per-view basis and many more people took out subscriptions during the lockdowns.

Improving on an existing online resource, the website company Ancestry were at the archives during the autumn to re-digitise our parish registers in higher definition and full colour. Mention should also be made of volunteers from the Glamorgan Family History Society who have returned after a gap of two years to continue their indexing of some of our other name-rich archives of interest to genealogists (in this case school records).

The figures for use of the Neath Mechanics Institute have been badly affected by the continuing lack of broadband which has meant in particular that there is no service there for family historians. Sessions run by the Neath Antiquarian Society on Thursday mornings have recorded a further 53 users, together with 39 volunteer visits.

2. National Broadcast Archive

Work has barely progressed on the National Broadcast Archive during the last quarter (now known as the Wales Broadcast Archive), which has caused some frustration both at this end and at the National Library of Wales. The cabling is in place for the area but the hardware to view the TV archive has not yet been delivered.

3. Outreach and educational activity

As reported last quarter, WGAS joined in an all-Wales bid for funds from the Anti-racist Wales Culture Heritage and Sport Fund, a bid which consisted of three potential projects. While two of these projects achieved funding, the one which was put forward by WGAS (the digitisation of archival material relating to Wales' links to the historic transatlantic slave trade) was not successful.

The first school to visit the archives since the pandemic was Gowerton Primary School which booked four sessions during the quarter.

Archives staff have also been in involved in discussions with Partneriaeth about the use of archives to meet the needs of the new Curriculum for Wales in teaching pupils how to research their local area. The first phase of this project will involve selected primary schools using archival resources at WGAS to develop a research question and start their research. WGAS will produce a video for them on how to get started. In the second phase, it is envisaged that the primaries will work with their associated secondary schools to develop a shared understanding of their local area and how it has developed over time. In the third phase, the schools will produce a video or other record of their primary/secondary school collaborative journey.

Undergraduate History students from Swansea University attended a session in the archive searchroom during the quarter.

The Service also had bookstalls at the Swansea Local History Bookfair and the Glamorgan History Society Day School.

4. Professional meetings and training

Archives staff have attended a number of professional working groups during the quarter as follows:

Archives and Records Council Wales Chief Archivists in Local Government Group Executive (CALGG) National Broadcast Archive Project Team (tbk as the Wales Broadcast Archive) The World Reimagined Welsh County Archivists Group

2026 will see the centenary of the first Adoption of Children Act, which made adoptions legal in England and Wales, leading to the setting up of agencies for adoption and later local government involvement. Since the earliest records will also soon be 100 years old, CALGG (referred to above) will be contacting local authorities across the country to investigate the survival and whereabouts of these earliest records and advocate for their deposit in local archives (they will be of interest to future family historians). The success of the project will be very dependent upon the cooperation and support of a wide range of record-keeping and care professionals across local government and the independent sector to ensure that national datasets of adoption records are both full and accurate.

5. Relocation of the archives

The design for the relocated archives is currently passing through RIBA Stage 4. This stage relates to technical design and the key factor here (as previously discussed) is that the archive storage area should conform to British Standard 4971 in providing for environmental stability within a set parameter of maximum and minimum environmental readings. As the project has progressed during the quarter, a number of technical modifications to the design have been made and a revised thermal model is awaited to see how these impact on the projected temperature and humidity. In this work, WGAS has been ably assisted by the National Conservation Service, who have also helped in preparing a detailed plan for the relocation of the archive collections.
