#(Item 1) – Planning Application 2022/2796/FUL - Vehicular access improvements, erection of a builders merchant including outside storage of materials and perimeter fencing, 2 no. drive thru units (Class A1/A3 uses), B2/B8 units, vehicle marketing suite (unique use) and associated development at Land Rear Of Dyffryn Close, Swansea Enterprise Park, Swansea

Report updated as follows:

A further written response has been submitted on behalf of the objector raising various issues which have been summarised as follows:

- The site is at flood risk which has been made worse by tree felling. The proposal is contrary to TAN15 and poses a flood risk to third party land and property.
- ii) Possible unidentified sewers and drains within the site.
- iii) Site pollution which requires further investigation.
- iv) Japanese Knotweed present.
