- 5. Responsible Authorities and other persons present will be invited to ask for any clarification in respect of the report presented.

Acceptable identification accepted by the premises licence holder, DPS, or other staff members shall be a passport, photo driving licence or pass accredited identity card.

The licence holder shall ensure that a refusals register is kept on the premises and that this shall be immediately available upon request of an authorised officer. The register shall record any refused sale of alcohol.

Signage shall be prominently displayed warning customers of the legal penalties for purchasing alcohol for any person under the age of 18 years.

There shall be a child exploitation policy





populated area due to being situated in a large council housing estate with many of those properties privately owned in a very close proximity to the applicant.

Convenience Stores and shops have historically attracted an element of anti social behaviour as they tend to be a congregational area.

The concerns in relation to such late opening hours are that this will attract an element of anti social behaviour with not only youths congregating but members of the public driving into the area due to no other convenience stores being open to such a late hour. This would create not only a high level of noise with vehicles but also persons talking and potential disorder due to persons already having consumed alcohol and wish to continue.

There are many families and elderly people living within this area which should the finishing hour of 02.00am be granted would have a detrimental effect on school children, members of the working public and the elderly.

It is the responsibility of the applicant to meet the four Licensing Objectives under the Licensing Act 2003, namely The Prevention of Crime and Disorder, Public Safety, The Prevention of Public Nuisance and The Protection of children from Harm.

I would suggest that on the balance of probabilities that having checked all the other premises in the Townhill/Mayhill area with their finishing hour being 23.00 that this venue will attract members of the public not only within this locality but outside the area to attend the store in high numbers.

This in turn could cause anti social behaviour, further alcohol issues and disturbances in the street due to public wanting to continue drinking at such a late hour.

The role of a Premises Licence holder requires a high level of responsibility and the ability to manage a licence premises to a competent and high standard on a day to day basis. The holder will be responsible for the safety of the public and any issues that could potentially arise in relation to the said premises which in turn would undermine the four Licensing Objectives.

South Wales police submit that this is a reasonable and proportionate response to this application and the above information is submitted for your information and consideration.



Thanks for your advice on this application, Please see the following:

On behalf of Myself, David Hopkins, and Lesley Walton Ward Members of Townhill Ward are not objecting to having an Off Licence at the above premises but are objecting to the closing Time of 02:00am. We feel that this would have a detrimental impact on the residents that live in the vicinity, We object on the following Grounds:

- 1: The prevention of public nuisance; For example: the opening/shutting of Car doors, people making noise or shouting outside the shop and on the streets, thus disturbing residents who live in the vicinity of this potential off licence. Also, that early in the morning will disturb law abiding residents that are sleeping.
- 2: The protection of children from harm. We also have concern for children hanging about outside the shop and consuming alcohol underage and then causing Anti-Social Behaviour.
- 3: Also having this facility here would encourage potential customers from other areas outside of the Ward to visit the premises again causing Nuisance and possible Anti-Social Behaviour.
- 4: We would also insist on the prospective Proprietor to install CCTV allowing Licencing/Police officers access to monitor over any 31-day period. We feel with this in place it would not only Protect the Proprietor/premises but also monitor any Anti-Social Behaviour out/inside the premises

To whom it may concern,

I am opposing the tender of 11 Mayhill Road to sell alcohol between the hours of 0800-0200 Monday to Sunday. I live and I find it ridiculous and unnecessary to sell alcohol this late in a residential area. This will only lead to attract antisocial behaviour. I also question the intentions of a business to sell alcohol this late in a residential area, knowing the problems that already exist in terms of drugs being dealt, which I witness regularly.

The 'Chicken King' store is already licenced until 0200 which leads to care and people outside the shop in the early hours, with delivery drivers coming back and forth, slamming car doors continuously. Parking is horrific in this area between all the shops with staff and customers, and people are constantly blocking my driveway. I feel that having an alcohol licence, or any licence for that matter, to stay open until 0200 will attract the wrong crowd and, as stated previously, encourage further antisocial behaviour. I have lived in my house for 25years. 20 years ago we had a lot of trouble with older teenagers by the shops causing trouble, smashing car windows, threatening behaviour. The council filmed this which lead to my house having to be wired-up to the central police station, so I'm sure you appreciate my anxieties in relation to selling alcohol until 0200 and encouraging this kind of behaviour. I am an NHS worker and have to be up for work every day at 0430, so I feel that this proposal will infringe on my ability to sleep. My sleep is already affected by the closing hours of Chicken King as my sleep is disturbed when the premises closes at 0230 when the staff leave work.

I also noted that from January 2022 there were plans for a restaurant for the same premises, which I would also oppose. I feel that this would cause major disruption due to the limited parking available on the main road and the increased noise pollution.

I will look forward to your response once you have taken my concerns into account.
