The Minutes of the meeting on the 23 November 2023 were agreed by the Panel.

108 Public Questions

No public questions were received.

109 Annual Education Performance against identified priorities including Estyn Inspection Update and Cabinet Member Q&A

The Panel thanked Councillor Robert Smith (Cabinet Member for Learning and Skills), Helen Morgan Rees (Director of Education), Kate Phillips (Head of

Vulnerable Learners) and Sarah Hughes (Education Strategy) for attending the Panel and presenting a writing report giving details about Education performance against identified priorities. The discussion covered:

- Progress with recommendations made by the Estyn Inspection of the Local Government Education Service in Swansea in 2022, including Post 16 Education and strengthening Welsh Language provision in Education. The Panel heard that good progress had been made with both recommendations.
- Progress against key priorities, some of these include for example:
 - Inclusion strategy
 - Attendance action plan
 - Embedding the requirements of the Additional Learning Needs Reform and Education Tribunal (Wales) Act 2018
 - Reviewing specialist provision
 - Embedding a whole school approach to emotional health and wellbeing
 - Support for looked after children
- The Panel heard that good progress had been made for most objectives and where specific aspects require attention, steps to address these have been identified.

The following issues/questions were raised by the Panel. A summary of the Panels views on progress made and the responses to their questions, will form part of the letter to the Cabinet Member sent following the meeting.

- Panel pleased to see good progress with both Estyn recommendations and asked was there an action plan to support these too and whether that could be included in future update.
- Who was consulted in the learner voice work, did it include 6th Form or all Post 16 for example those in vocational education.
- Possible new special school. Will travel to the new school have an impact for those using it as it will be based on one site rather than two.
- Data comparison. Would it be more realistic to compare current data with that of 2019 rather than the last few years at the moment. Also, a useful measure might be to look at destination indications like those pupils getting their 1st and 2nd choice university place.
- What support is provided to Headteachers both in relation to inspections and more widely.
- When school is in special measures or Estyn monitoring, how does the local authority monitor progress.
- How do the LA and schools support armed forces children.
- PISA results, do we have results for the Swansea area.

The Panel asked the Cabinet Member and Director to thank both the Education Directorate and schools for their excellent work this year.

110 Feedback from Partneriaeth Scrutiny Councillor Group

Councillor Lyndon Jones updated the Panel about Partneriaeth Scrutiny which included sharing the letter to the Chair of the Joint Committee from the Councillor Group following their last meeting on the 23 October 2023.

The Panel welcomed the update with regard to Partneriaeth Scrutiny and felt it was useful to have copies of the letters. One of the issues raised in the letter was regarding the training, development and support provided by Partneriaeth and was this available to school governors.

Summary: This is a letter from the Education Scrutiny Performance Panel to the Cabinet Member for Education and Learning following the meeting of the Panel on 23 November 2023. The Panel discussed looked after reducing disadvantage in schools, the School Improvement Services and Cookery in school.

Dear Cllr Smith,

Education Scrutiny Performance Panel – 23 November 2023

We would like to thank you, the Director of Education, Head of Planning and Resources, Principal School Improvement Officer and Head of Achievement and Partnership Service for attending the meeting and providing information for the Panel. We are writing to you to reflect on what we learnt from the discussion and to share the views of the Panel.

Reducing disadvantage in school

We heard about how the Education Directorate and schools work to reduce disadvantage in schools including the use of the Pupil Development Grant (PDG), the roll out of free school meals, the cost of the school day and school uniform. The main aim of this is to raise the attainment of pupils from low-income households by reducing the barriers they face in achieving their full potential.

We were told that the PDG received by schools can vary greatly depending on the number of pupils eligible. When using the grant, it has been found that some interventions are more successful than others and the best approaches are not always the most expensive. We were pleased to hear that approaches used should be research and evidenced based.

We asked how the level of pupil development grant to schools will be determined in the future, given the free school meal (FSM) proxy may no longer be as accurate due

to parents having less incentive to register because of the roll out of FSM. We were told that schools are constantly reminding parents to register, also because it enabled them to access the possibility of a grant for school uniform.

You told us that the FSM indicator is probably not the ideal proxy for deprivation in schools, but it is the best we have for now. A two-pronged approach will need to be used, firstly, continuing to get parents to register but also, secondly, to look at other indicators of deprivation.

We also asked whether good practice examples in reducing disadvantage are being shared across schools. We heard that PDG guidance to practitioners and leaders in Wales on the use of this grant is predominantly around whole school approaches. So those approaches, once embedded, are shared in a variety of ways. One way is through our SIT sharing that knowledge across the system as they visit schools. We also heard that this is done via case studies and at head teacher seminars, where we invite our school leaders to present some of their good practice. Partneriaeth share practice as well and Estyn published case studies once they have inspected schools.

We were interested to hear how awareness is being raised across schools about the barriers faced by pupils caused by deprivation. We agreed that the poverty proofing of the schools day is a good way to identify and make practical changes in schools based on what pupils really need to enable them to partake fully in their education.

School Improvement Service (SIT) Update

We heard that SIT support schools in a number of ways through the school year but the core of the work centres around annual support visits. The agenda for visits are co-constructed with headteachers in order to support high levels of ownership and engagement. One of the key objectives for the last academic year was to support schools in self-evaluation. Schools were encouraged to self-evaluate in the areas of vision and leadership; curriculum, learning and teaching and wellbeing, equity inclusion. We heard that this year SIT is focusing on

- A differentiated/graduated approach to the number of school visits per school depending on the level of need.
- Supporting schools and settings to have a clear rationale for their priorities.
- Supporting schools to plan for improvement in a more focused manner.
- Improving the quality of school-based evaluations.
- Supporting schools to undertake purposeful quality assurance that promotes an improving view of pupil progress, the impact of their curriculum plans and the provision to promote positive wellbeing.

We asked what the differing roles are between the SIT and Partneriaeth. We heard Partneriaeth provide curriculum support and development in aspects of the national leadership programme including training that enables practitioners to do what they need to do at the chalkface. While the SIT is a separate team that sits within the local authority whose role it is evaluate schools and their improvement journey.

We thanked the SIT and wished to note that we appreciate the excellent support they are providing to our schools in Swansea.

Cookery in Schools Briefing

We heard that cookery within schools falls within the Health and Well-being area of the Curriculum for Wales, where learners are helped to understand factors that affect health promoting behaviours. As a result, learners should be taught the importance of a balanced diet, nutrition and the impact of choices on well-being; how to plan and prepare basic, nutritious meals and applying a range of techniques to prepare meals. The report also provided us with a snapshot of where we are now in both the primary and secondary sector in Swansea.

We agreed that Penclawdd was a shining example of what can be done and asked if there was any strategy at this stage to consider rolling out that learning more widely. Although we do recognise some of the difficulties with that, not least the finding of the physical space in each school. We heard that there is not a specific strategy but it does sit under a much wider strategy in relation to poverty and is about how we support our families. In the longer term, it may need to be a Welsh national strategy rather than an individual local authority that pushes some aspects forward.

We also asked how often a child actually gets to cook in school. We were told that there would not be any data specifically saying how often it is. It would be down to individual schools to determine, as part of their design of the curriculum and how they blend that in. Although we were told there is more anecdotal evidence similar to Penclawdd Primary School in how schools in their work as community focused schools are making it a much wider offer and bringing the families in.

We were encouraged to hear that it is part of the new curriculum but do feel that cookery and nutrition is a serious issue and an important life skill. Schools should ensure that it is clearly part of their curriculum planning. A start needs to be made if we are to be serious about this work.

Summary: This is a letter from the Education Scrutiny Performance Panel to the Cabinet Member for Education and Learning following the meeting of the Panel on 14 December 2023. The Panel discussed the Annual Education Performance including an Estyn Inspection recommendation progress update.

Dear Cllr Smith,

Education Scrutiny Performance Panel – 14 December 2023

We would like to thank you, the Director of Education and the Team Manager Education Strategy for attending the meeting and providing information for the Panel. We are writing to you to reflect on what we learnt from the discussion and to share the views of the Panel.

Annual Education Performance against identified priorities including Estyn Inspection recommendation progress update

We were told that good progress has been made with both the recommendations from the Estyn Inspection of the Local Government Education Service in Swansea in 2022, which included recommendations on post-16 education and strengthening Welsh Language provision in Education.

We heard about progress with the pupil voice consultation in relation to post-16 education, hearing that an extensive learner survey took place in 2023 with sixth form learners. We asked whether other post-16 pupils were consulted i.e., those doing vocational education and/or at Gower College. We heard that the survey originally covered just sixth form pupils but was then extended to other post-16 pupils, although we heard that the response from Gower College pupils was not as good as was hoped. The Panel agreed that vocational and other courses can be a very different 'offer' and it is important to understand those young people's views.

We were pleased to hear that both the Inclusion Strategy and the School Attendance Action Plan had been agreed and are now active.

We were interested to hear about the review of specialist provision and the possibility of a new state of the art special school that would replace Ysgol Pen-yr-Bryn and Ysgol Crug Glas in Swansea (noting that this will not replace our current STF provision). We look forward to hearing more about this in the future as the proposal progresses.

We discussed the Key Stage 4 and advanced level results data and recognised that comparison of 2020, 2021 and 2022 would not be useful but we did suggest that it might be more realistic to compare between 2023 current data and that of 2019 prior to the pandemic. We also felt that it would also be useful to look at pupil destination information like, for example, those pupils getting their 1st and 2nd choice university place.

We were told that seventeen schools had been inspected by Estyn in the last academic year, five of these will be followed up by Estyn, with one school being placed in special measures. We asked how the local authority monitors progress with schools that are placed in follow up or special measures and heard that a School Improvement Adviser is assigned to a range of schools. When schools are in one of these categories the Adviser will work intensely with the school and will have done so both pre and post inspection. We also heard that bespoke training, for example, for new and acting leaders may be offered as well as support for new governance arrangements through the Councils Governor support Unit.

We also heard that there are currently two post inspection action plans for any school that goes into a statutory category: the local authorities plan and the post inspection plan. We were pleased to hear that Estyn recognised the burden of having two plans and they are now going to splice those plans together from January.

We were encouraged to hear that there were also six Estyn case studies indicating that in those six Swansea schools there is exceptional practice.

We were interested to explore the support that is provided to Headteachers both in relation to the pressure of inspections and other serious issues they may experience in their schools. We were told that the Local Authority do provide a range of support mechanisms including counselling and stress management. We noted that there is a self-referral system currently, which means that headteachers do not need to go to their chair of governors to be referred to counseling. The Council is also trying to remedy some things before they become an issue, hearing that there are range of factors that could impinge on wellbeing that are being looked at, for example, most recently ways to reduce the bureaucratic workload burden.

We were pleased to hear that Estyn have changed the way they inspect and have adapted the inspections to support the wellbeing needs of leaders and school staff and judgements have been removed and replaced with a narrative outcome designed to support improvement.

We asked how the Local Authority and schools support armed forces children. We heard that the Local Authority has strong links around this and that there is also financial support for armed forces pupils, as long as we know about them.

We asked about the PISA results and whether we could see the breakdown for Swansea. We heard local authorities are not provided with the outcome data for PISA and that pupils are chosen randomly across schools in Wales so providing a breakdown of data for Swansea specifically is not possible.

The Panel were pleased to hear that good progress had been made with most of the Education identified priorities. We were told that where specific aspects require attention, steps to address these have been identified.

The Panel asked the Cabinet Member and Director to pass their thank you to both the Education Directorate and schools for their excellent work this year.

Partneriaeth Scrutiny

We discussed the most recent Partneriaeth Scrutiny letter to the Chair of the Partneriaeth Joint Committee, where an issue was raised about the training, development and support provided by Partneriaeth and whether this was available to school governors. The Panel asked how this was utilised in Swansea. Helen Morgan Rees agreed to speak to our Governor Support Unit to see how this is and can be linked to our current governor development programme.
