#### Councillors

**Councillors Interests are made** in accordance with the provisions of the Code of Conduct adopted by the City and County of Swansea. You must disclose orally to the meeting the existence and nature of that interest.

**NOTE:** You are requested to identify the Agenda Item / Minute No. / Planning Application No. and Subject Matter to which that interest relates and to enter all declared interests on the sheet provided for that purpose at the meeting.

- If you have a Personal Interest as set out in Paragraph 10 of the Code, you MAY STAY, SPEAK AND VOTE unless it is also a Prejudicial Interest.
- If you have a Personal Interest which is also a Prejudicial Interest as set out in Paragraph 12 of the Code, then subject to point 3 below, you MUST WITHDRAW from the meeting (unless you have obtained a dispensation from the Authority's Standards Committee)
- 3. Where you have a Prejudicial Interest you may attend the meeting but only for the purpose of making representations, answering questions or giving evidence relating to the business, provided that the public are also allowed to attend the meeting for the same purpose, whether under a statutory right or otherwise. In such a case, you must withdraw from the meeting immediately after the period for making representations, answering questions, or giving evidence relating to the business has ended, and in any event before further consideration of the business begins, whether or not the public are allowed to remain in attendance for such consideration (Paragraph 14 of the Code).
- 4. Where you have agreement from the Monitoring Officer that the information relating to your Personal Interest is **sensitive information**, as set out in **Paragraph 16** of the Code of Conduct, your obligation to disclose such information is replaced with an obligation to disclose the existence of a personal interest and to confirm that the Monitoring Officer has agreed that the nature of such personal interest is sensitive information.
- 5. If you are relying on a **grant of a dispensation** by the Standards Committee, you must, before the matter is under consideration:
  - i) Disclose orally both the interest concerned and the existence of the dispensation; and
  - ii) Before or immediately after the close of the meeting give written notification to the Authority containing:

- a) Details of the prejudicial interest;
- b) Details of the business to which the prejudicial interest relates;
- c) Details of, and the date on which, the dispensation was granted; and
- d) Your signature

#### Officers

#### **Financial Interests**

- 1. If an Officer has a financial interest in any matter which arises for decision at any meeting to which the Officer is reporting or at which the Officer is in attendance involving any member of the Council and /or any third party the Officer shall declare an interest in that matter and take no part in the consideration or determination of the matter and shall withdraw from the meeting while that matter is considered. Any such declaration made in a meeting of a constitutional body shall be recorded in the minutes of that meeting. No Officer shall make a report to a meeting for a decision to be made on any matter in which s/he has a financial interest.
- 2. A "financial interest" is defined as any interest affecting the financial position of the Officer, either to his/her benefit or to his/her detriment. It also includes an interest on the same basis for any member of the Officers family or a close friend and any company firm or business from which an Officer or a member of his/her family receives any remuneration. There is no financial interest for an Officer where a decision on a report affects all of the Officers of the Council or all of the officers in a Department or Service.

- 1.3 The ToR provides for a "Gower AONB Partnership" a body open to any individual or organisation with an interest in the AONB. This will provide the overall body in which the management of the AONB is undertaken.
- 1.4 The AONB Partnership will nominate a Steering Group, which will act as the management group of the AONB, primarily overseeing the development and implementation of the AONB Management Plan, and the coordination of the day-to-day management of the AONB. The nominations will be endorsed by the Council.
- 1.5 The AONB Steering Group includes Councillors and representatives from Natural Resources Wales, and 10 other representatives nominated by the Partnership.

## 2.0 Background

- 2.1 The Countryside and Rights of Way (CRoW) Act 2000 places a duty upon the City & County of Swansea ('the Council') to "prepare and publish a management plan which formulates their policy for the management of the Area of Outstanding Natural Beauty and for the carrying out of their functions in relation to it".
- 2.2 The Act also places a statutory duty on relevant authorities to have regard to the purpose of conserving and enhancing the natural beauty of the AONB when exercising or performing any functions affecting land in the AONB. "Relevant authorities" are any public bodies including local and statutory authorities, parish councils and statutory regulators.

## 3.0 Proposals

- 3.1 The current ToR allows for the annual election of the 10 other representatives.
- 3.2 The AONB Steering Group has requested that the ToR be amended to allow the appointments to be for a term of 2 years. This is to help retain the knowledge of those representatives within the Steering Group, and to increase the effectiveness of the group through greater continuity. This continuity is seen as particularly important during the formal review of the AONB Management Plan which is currently underway.
- 3.3 Steering Group meetings are open to the public, and minutes and other documents of the Steering Group will continue to be made available to the public through the AONB website.

3.6 The AONB Partnership will hold an annual meeting, which will aim to engage with the public, and celebrate the AONB and the work undertaken by the partners. The meeting will also include the nomination of Steering Group members.

## **GOWER AONB Partnership - Terms Of Reference**

## **PURPOSE & FUNCTION**

- 1) The Countryside and Rights of Way (CRoW) Act 2000 places a duty upon the City & County of Swansea ('the Council') to "prepare and publish a management plan which formulates their policy for the management of the Area of Outstanding Natural Beauty and for the carrying out of their functions in relation to it".
- 2) The Act also places a statutory duty on relevant authorities to have regard to the purpose of conserving and enhancing the natural beauty of the AONB when exercising or performing any functions affecting land in the AONB. "Relevant authorities" are any public bodies including local and statutory authorities, parish councils and statutory regulators.
- 3) The Gower AONB Partnership ('The AONB Partnership ') is an advisory group to the Council, convened by them, to facilitate the management of the Gower AONB, in fulfilment of their legal responsibilities and duties with regard to the Gower AONB.

## STRUCTURE AND PURPOSE

- 4) **The AONB Partnership** is a membership body, open to any individual or organisation. The only criteria is that they should have an interest in the AONB. The AONB Partnership is an overarching group set up in order to co-ordinate management groups set up under its cover. The AONB Partnership is intended to support the involvement of the community in the management of the AONB
- 5) The AONB Partnership will be chaired by the Councillor who is Chair of the Development Management & Control Committee.
- 6) The AONB Partnership is responsible for nominating the **Gower AONB Partnership Steering Group** ('the Steering Group').
- 7) The Steering Group is responsible for overseeing the Management of the AONB, and is responsible for the development of policy and strategy for the AONB area, particularly through the AONB Management Plan, and influencing the policies and strategies of others. The Steering Group will also take and support action to conserve and promote the AONB.
- 8) The Steering Group will comprise:
  - a maximum of 6 Councillors (including the Councillor who is Chair of the Development Management & Control Committee).
  - 2 representatives from Natural Resources Wales
  - 10 other members who will be elected for a term of two years, drawn from the following interests as appropriate:

- Community Councils
- Nature conservation
- History and archaeology
- Land owning/farming/forestry
- Commoners
- Rural business
- Tourism
- Recreation
- Local Interest Groups
- Residents of the Gower AONB
- 9) The Steering Group will be chaired by the Chair of the Development Management & Control Committee.
- 10) . The Steering Group will select a Vice Chair from the Steering Group Members.
- 11) The Steering Group will elect the following sub-groups to the Steering Group:

## a) Sustainable Development Fund (SDF) Grants Panel.

- This panel will decide on grant applications to the SDF from funding obtained from the Welsh Government. It will determine how best to use that funding, and will operate an appeals process when considering how funding should be spent.
- This panel will comprise the Chair of the Development Management & Control Committee (who will act as Chair) and seven other members of the AONB Partnership.
- The panel will be supported by the AONB Officer, and a representative from NRW, as observers.

## b) The SDF Grants Appeals Panel

- This Panel will handle disputes on how funding should be spent and will decide on appeals for grant applications refused by the SDF Grants Panel.
- The SDF Appeals Panel will comprise the Vice Chair of the Steering Group (who will act as Chair of the SDF Appeal Panel) and seven other members of the AONB Partnership that do not already sit on the SDF Grant Panel.
- The panel will be supported by the AONB Officer, and a representative from NRW, as observers.

## c) Other sub-groups as required

- 12) The Steering Group will have the power to co-opt individuals (to itself, or to sub-groups) or organisations or to set up further sub-groups as deemed necessary to fulfil the aims and objectives of the AONB Partnership.
- 13) Members of the Steering Group and of any sub-group will be expected to abide by the City and County of Swansea Members Code of Conduct.

## AIMS AND OBJECTIVES


- 14) **The Steering Group** are responsible for:
  - Preparation of the AONB Management Plan on behalf of the City & County of Swansea.
  - Co-ordination of the implementation of the AONB Management Plan.
  - Develop and implement a programme of promotion and awareness of the special qualities of the AONB and the Heritage Coast.
  - Preparation of business plans for the Partnership including the annual work programme for the AONB Team.
  - Preparation of an annual report on the work of the Partnership and progress on implementing the AONB Management Plan.
  - Securing additional resources for the implementation of the Management Plan.
  - Commission research and special studies.
  - Operation of the Sustainable Development Fund on behalf of NRW and the Welsh Assembly Government.
  - The running of sub-groups as required
  - Holding an annual forum.
  - Holding an annual meeting with Community Councils and City & County of Swansea councillors with wards in the AONB.
  - Communication amongst the Partnership.
  - Forging links with other fora and protected landscapes, including National Parks, through the National Association for AONBs and the Europarc Federation.

## MEETINGS

- 15) **The AONB Partnership:** will meet annually, with the purpose of the meeting to:
  - nominate the Steering Group members as required
  - engage with the public to promote awareness of the AONB and its special qualities
  - report and review the AONB management over the previous year; and
  - identify issues, opportunities and priorities for the coming year.
- 16) An officer from the City & County of Swansea Democratic Services will be present at all meetings to record proceedings. Minutes of each meeting shall be kept and circulated to Steering Group members as soon as possible after each meeting, and made available to the public on the AONB website.
- 17) **The Steering Group:** will meet quarterly, and the meeting dates published annually. Additional meetings will be convened if required. In the absence of the Chair or Vice-Chair at a meeting then the Steering Group may elect a Chair for that meeting. The quorum for Steering Group meetings will be six.

- 18) All meetings of the Steering Group will be open to the public for observation. Each meeting will start with a maximum of ten minutes for public questions relevant to items on the agenda.
- 19) Decisions by the Steering Group shall be made by show of hands with the Chairman having the casting vote.
- 20) **The SDF Grants Panel:** will be called to meet by the Grants Panel members and advised by the AONB Team and NRW representative, determined by the timing and number of applications to received. Quorum of the SDF Grants Panel will be four.
- 21) **The SDF Appeals Panel:** will be called to meet by the Grants Panel and advised by the AONB Team and NRW representative, determined by the timing of appeals received. Quorum of the SDF Appeals Panel will be four.
- 22) Further information in relation to the election of Steering Group Members and other procedural matters can be found in the Gower AONB Partnership Procedural/ Guidance notes available from the AONB Team.

## 1. Introduction

1.1 In compliance with the Local Government Act 2000, the City & County of Swansea has adopted a Council Constitution. A number of issues have arisen since adoption and in order to maintain the aims, principles and procedures set out in Articles 1 and 15 of the Council Constitution, it is proposed that the amendments set out below should be made to the Constitution.

- 3.2.1 The Audit Committee recently undertook a review of its performance using a self assessment checklist provided by CIPFA. The review identified a small number of areas where the Committee felt that improvements could be made to ensure that the Committee was following best practice.
- 3.2.2 A summary of the issues identified during the performance review was reported to the Audit Committee 24<sup>th</sup> April 2014 where it was agreed that action would be taken to address the issues identified.
- 3.2.3 One of the issues identified related to the Committee's terms of reference which appear in Part 3 of the Council's Constitution and are attached in Appendix 1.
- 3.2.4 In 2013, CIPFA published *Audit Committees Practical Guidance for Local Authorities and Police Bodies* which included model terms of reference for Audit Committees. The model terms of reference published by CIPFA are attached in Appendix 2.
- 3.2.5 The model terms of reference proposed by CIPFA are consistent with the Local Government (Wales) Measure 2011 which requires the Council have an audit committee.
- 3.2.6 The Audit Committee felt that the model terms of reference put forward by CIPFA provided a better basis for the Committee to fulfil its core functions and wished to adopt the terms of reference shown in Appendix 2

## 4. Equality and Engagement Implications

## **CIPFA – Audit Committee Model Terms of Reference**

## Statement of Purpose

- 1. Our audit committee is a key component of the City and County of Swansea's corporate governance. It provides an independent and high level focus on the audit, assurance and reporting arrangements that underpin good governance and financial standards.
- 2. The purpose of our audit committee is to provide independent assurance to the members of the adequacy of the risk management framework and the internal control environment. It provides independent review of the City and County of Swansea's governance, risk management and control frameworks and oversees the financial reporting and annual governance processes. It oversees internal audit and external audit, helping to ensure efficient and effective assurance arrangements are in place.

## Governance, Risk and Control

- 3. To review the Council's corporate governance arrangements against the good governance framework and consider annual governance reports and assurances.
- 4. To review the Annual Governance Statement prior to approval and consider whether it properly reflects the risk environment and supporting assurances.
- 5. To consider the Council's arrangements to secure value for money and review assurances and assessments on the effectiveness of these arrangements.
- 6. To consider the Council's framework of assurance and ensure that it adequately addresses the risks and priorities of the council.
- 7. To monitor the effective development and operation of risk management in the Council.
- 8. To monitor progress in addressing risk related issues reported to the committee.
- 9. To consider reports on the effectiveness of internal controls and monitor the implementation of agreed actions.
- 10. To review the assessment of fraud risks and potential harm to the Council from fraud and corruption.
- 11. To monitor the counter fraud strategy, actions and resources.

## Internal Audit and External Audit

- 12. To approve the internal audit charter and resources.
- 13. To consider the head of internal audit's annual report and opinion, and a summary of internal audit activity (actual and proposed) and the level of assurance it can give over the Council's corporate governance arrangements
- 14 To consider summaries of specific internal audit reports as requested
- 15. To consider reports dealing with the management and performance of the providers of internal audit services.
- 16. To consider a report from internal audit on agreed recommendations not implemented within a reasonable timescale.
- 17. To consider the external auditor's annual letter, relevant reports, and the report to those charged with governance.
- 18. To consider specific reports as agreed with the external auditor.
- 19. To comment on the scope and depth of external audit work and to ensure it gives value for money.
- 20. To commission work from internal and external audit.

## **Financial Reporting**

- 21. To review the annual statement of accounts. Specifically, to consider whether appropriate accounting policies have been followed and whether there are concerns arising from the financial statements or from the audit that need to be brought to the attention of the Council.
- 22. To consider the external auditor's report to those charged with governance on issues arising from the audit of the accounts.

## **Accountability Arrangements**

23. To report to full Council on a regular basis on the committee's performance in relation to the terms of reference and the effectiveness of the committee is meeting its purpose.

	Does this question indicate that the Independent Group is on Conservative Central Office's mailing list and does this question finally begin to clarify the Group's true political leanings? I think Council should be told.

As the funding was of a limited amount, it was to be allocated to those local authorities facing the greatest challenges.

	The main condition of funding was that each bid must be supported by

confirmation that the local authority forecasts to fully utilise and exceed its main DHP allocation. It should be noted throughout 2013/2014 the DHP expenditure and applications received were carefully tracked to monitor both demand and spend

The final DHP expenditure resulted in an overspend of only  $\pounds$ 1,213 which is borne by the Council.

Therefore this authority was unable to satisfy the main condition to support a bid.

The scale of activity within the Council resulted in1,871 Discretionary Housing Payments being made during the year totalling some £575,000. All applications which met the adopted DHP criteria in Swansea were approved.

## Providing Council with Written Responses to Questions at Council – 15 April 2014

## 1. Councillor MH Jones asked the Cabinet Member for Regeneration

## Question

What the Board of the Wales National Pool Swansea had done and were doing in order to offset the difficult challenges it faced following the removal of its International Training Camps (ITC) status?

## **Response of the Cabinet Member for Regeneration**

The Board and management representatives have held a number of meetings with Swim Wales to consider the impact of the loss of the ITC status at the Wales National Pool. Swim Wales have indicated that they are intent on maintaining a centre of excellence at the pool for both able bodied and disabled swimmers. In addition, an extensive pool space review has been undertaken and alternative users and additional space has been identified in order that income can be generated to offset the income lost as a result of British Swimming's decision to reduce the number of ITC's in the UK

## 2. Councillor PR Hood-Williams asked the Cabinet Member for Regeneration

## Question

Page 102, Paragraph 4.8 "Liberty Stadium" which states "Before any distribution of profit could be considered the Company would have to be in a position of net profitability taking account of past accumulated losses. There is therefore considerable progress to be made in terms of profitability before any distribution could be made."

1) How much has the loss been and what is the current amount of the loss i.e. how much is left?

2) The actual income 2012-2013 from the Swans is £1,306,544 and from the Ospreys is £207,450. The turnover of the Swans and Ospreys is far higher. How the income amount is therefore calculated.

## **Response of the Cabinet Member for Regeneration**

The 2012/13 performance by SSMC was that the Company reported post-tax profit for the year of £269,992; this is based on turnover of £3,103,936 against turnover of £2,692,304 in the previous financial year, and a post-tax profit of £159,891 in the previous financial year. At the start of the 2012/13 financial year SSMC carried forward accumulated losses of £396,426; when the post-tax profit is considered against that figure the accumulated losses at the 2013 financial year end reduced to £126,764. As per the report, SSMC envisage to clear this deficit by the end of their 2013/14 financial year (May  $31^{st}$ ).

Total Income was £3,103,936 which includes apportioned income from gate receipts at Swans and Ospreys matches, including apportioned season ticket sales, and also Premier Club including Executive Boxes, catering concession fee, rentals, concert and event income and other sundry commercial income.

## 3. Mrs L Davies asked the Cabinet Member for Learning & Skills

## Question

In relation to Minute 223 "Welsh in Education Strategic Plan 2014-2017".

- 1) Has the council received any such grant funding? [If yes];
- 2) What was the total amount of grant funding awarded for 2013-2014?
- 3) Which schools were the recipients of the grant funding?
- 4) How will the introduction of the Welsh Education Strategic Plan benefit those children living in Swansea who are being denied the opportunity to take the full course Welsh GCSE through normal educational channels and are having to take twilight classes, after school?

## **Response of the Cabinet Member for Learning & Skills**

- 1) All authorities in Wales receive Welsh in Education grant funding.
- 2) In Swansea in 2013-14 £342,881 was received from Welsh Government.

3) All schools benefit from part of the WEG. The grant covers Welsh-medium schools where it supports Welsh as a first language and English-medium schools. In English-medium primary schools the grant is very important because it supports the training of teachers to deliver Welsh as a second language which some schools find it difficult to provide. The allocation across English and Welsh medium, primary and secondary, schools is agreed each year by the consultative group Partneriaeth Addysg Cymraeg Abertawe (PACA).

4) The WEG funds a Welsh in Education Officer who works in Englishmedium secondary schools promoting and supporting Welsh as a second language. She has been successful in raising the profile of Welsh and provision is increasing. She has encouraged some schools to provide the required time for Welsh second language within the curriculum, to make it a compulsory subject at GCSE and to offer the full course and not just the short course.

In other schools, where changing the curriculum is taking more time, additional classes have been offered after school so pupils who wish to can sit the full course at GCSE.

## 4. Councillor PM Meara asked the Cabinet Member for Learning & Skills Question

Page 17, Paragraph 3 refers to Partneriaeth Addysg Cymraeg Abertawe (PACA).

- 1) Is PACA a decision making body?
- 2) Are there any Elected representatives on PACA?
- 3) What are the Authority's Scrutiny arrangements for PACA?
- 4) How effective and reliable is that data?

## Response of the Cabinet Member for Learning & Skills

1) The consultative group Partneriaeth Addysg Cymraeg Abertawe (PACA) guides the authority's development of most of the requirements of the Welsh in Education Strategic Plan (WESP). The QEd 2020 programme guides the requirements to do with school organisation and the provision of places. PACA is required to advise on decisions, for example, on the use of the Welsh in Education Grant (WEG) funding or changes in practice.

2) The membership of PACA is stated in 1.6 in the WESP and does not include any Elected Members

3) The work of PACA is to deliver the WESP which is focused on raising standards in Welsh in Education, specifically pre-school and in-school. There has not been any scrutiny of the mandatory WESP so far. The authority's performance in *all* areas of Education is reported to Scrutiny annually in late autumn.

The data used in this report is based on that provided by the Fisher Family Trust.

4) Fischer Family Trust information is used by both English and Welsh governments and by all local authorities in both countries. The huge volume of pupil data collected over more than a decade means that the models used are sufficiently robust for use in estimating and prediction. Fischer now claim 85% reliability which is a very good rating (previously c. 70%). Swansea has developed such a high standard of data in its schools, following many years of guidance by the authority, that the accuracy is probably even higher here. Attached is a document provided by Fischer which you may find useful.

## Scrutiny and sustainability – improving the impact

(Lead: Councillor Mike Day)

Scrutiny councillors recently got together to explore how the scrutiny function in Swansea can drive long term, preventative decision making through its work. A workshop was held in March to:

- develop skills and knowledge on future trends
- have a better understanding of how to use sustainability principles to ensure services are 'fit for purpose'
- understand the potential impacts of the forthcoming Future Generations Bill
- understand how the scrutiny function can make an bigger impact by adopting sustainable development as a central organising principle

There was specific discussion on long term trends, sustainable development and the role of scrutiny, current and future influences on scrutiny and learning from others. The development session was focussed on improving the impact of scrutiny in the context of the Future Generations Bill in particular. In terms of next steps a follow up event is expected in order to reflect on the workshop and difference made, but there were some immediate points that emerged:

- need to feed in some of the 'future risks' issues into the work planning conference as possible inquiry topics
- need to develop a short checklist that ensures future risks / future generations issues can be considered as part of inquiry scoping
- look at having a 'people centred' inquiry that looks at the combined impact of a range of issues on a typical household
- explore the option of undertaking scrutiny as a one day 'commission' involving range of stakeholders and the public
- finally, if last year was about introducing new arrangements, this year about bedding them down, next year should be about ensuring impact

The workshop was supported by the Welsh Local Government Association (WLGA) and run by PwC and Netherwood Sustainable Futures. This is part of a package of work that is being delivered as the City & County of Swansea is the pilot authority for the WLGA on Sustainable Development.

## Are we scrutinising school improvement effectively?

(Lead: Councillor Jennifer Raynor)

The Schools Performance Scrutiny Panel are evaluating their year's work to start planning for the coming municipal year. They will look at what has gone well, what has not gone so well, and whether they are focussing on the right issues and identify learning points from the year. The purpose of this will be to continually improve how the Panel scrutinise the work education services in Swansea. The Panel's next step will be to start thinking about what the key issues might be over the coming twelve months to ensure they are making the most of the time they have to examine this subject.

## The waiting list for social housing

(Lead: Councillor Terry Hennegan)

One of the scrutiny working groups held recently focussed on exploring the idea of introducing a single waiting list for social housing in Swansea that covers the Council and all Registered Social Landlords (RSLs). Following a meeting about the feasibility of this change it was accepted that it would not be desirable to push forward with the development of a single housing waiting list at this time however the focus should be on ensuring there can be as swift a process for housing applicants for obtaining housing that meets their needs. The Cabinet Member for Wellbeing has now provided a response to the views and recommendations made by the Working Group and has agreed that these will improve methods of accessing social housing for those that need it and also improve the information available to Councillors on the issue. This includes:

- making the development of a common method of accessing social housing in Swansea a priority for the Housing Service
- encouraging RSLs to ensure that council officers are informed in advance of when their waiting lists will be closed and also informed when they will be re-opened and for what period of time
- reviewing and improving the information that is provided to Councillors about the role of RSLs and their allocation criteria

## Following up previous inquiry reports

Over the last year six Scrutiny Inquiry reports have been published and presented to Cabinet. After a scrutiny report is presented Cabinet is then required to formally respond to the recommendations made to it within three months. This would entail a report back to Cabinet from the relevant Cabinet Member(s) with a view on the recommendations to inform the cabinet decision, together with a draft action plan. Four of the six Inquiry Reports have been responded to, resulting in 86% of recommendations being fully accepted with a further 7% being accepted in part. Following up on this work is an important part of the scrutiny process - to check that actions agreed by cabinet have been carried out in response to scrutiny recommendations, and assess the impact made. Arrangements will be made for each of the Inquiry Panels to reconvene for the purpose of follow up and this is likely to happen between six and twelve months from the cabinet decision, whatever is the best time to evaluate the difference made. It is envisaged that Inquiry Panels will use the opportunity to follow up by not just receiving a progress report from the relevant cabinet member(s) but by engaging more widely with those involved in the inquiry and others to obtain a better picture of improvement.

## And the survey says...

(Lead: Councillor Mike Day)

Around 55% of non-executive councillors completed the annual councillor scrutiny survey. The results were considered by the Scrutiny Programme Committee as part of its annual work programme review. Some of the headlines from the results are:

- 73% agreed that the scrutiny arrangements were working well
- 87% agreed that scrutiny works in a cross cutting fashion and not restricted to departmental silos
- 91% agreed that non-executive members have good opportunities to participate in scrutiny
