Councillors Interests are made in accordance with the provisions of the Code of Conduct adopted by the City and County of Swansea. You must disclose orally to the meeting the existence and nature of that interest.

NOTE: You are requested to identify the Agenda Item / Minute No. / Planning Application No. and Subject Matter to which that interest relates and to enter all declared interests on the sheet provided for that purpose at the meeting.

- If you have a Personal Interest as set out in Paragraph 10 of the Code, you MAY STAY, SPEAK AND VOTE unless it is also a Prejudicial Interest.
- 2. If you have a Personal Interest which is also a **Prejudicial Interest** as set out in **Paragraph 12** of the Code, then subject to point 3 below, you **MUST WITHDRAW** from the meeting (unless you have obtained a dispensation from the Authority's Standards Committee)
- 3. Where you have a Prejudicial Interest you may attend the meeting but only for the purpose of making representations, answering questions or giving evidence relating to the business, provided that the public are also allowed to attend the meeting for the same purpose, whether under a statutory right or otherwise. In such a case, you must withdraw from the meeting immediately after the period for making representations, answering questions, or giving evidence relating to the business has ended, and in any event before further consideration of the business begins, whether or not the public are allowed to remain in attendance for such consideration (Paragraph 14 of the Code).
- 4. Where you have agreement from the Monitoring Officer that the information relating to your Personal Interest is sensitive information, as set out in Paragraph 16 of the Code of Conduct, your obligation to disclose such information is replaced with an obligation to disclose the existence of a personal interest and to confirm that the Monitoring Officer has agreed that the nature of such personal interest is sensitive information.

Officers

Financial Interests

- 1. If an Officer has a financial interest in any matter which arises for decision at any meeting to which the Officer is reporting or at which the Officer is in attendance involving any member of the Council and /or any third party the Officer shall declare an interest in that matter and take no part in the consideration or determination of the matter and shall withdraw from the meeting while that matter is considered. Any such declaration made in a meeting of a constitutional body shall be recorded in the minutes of that meeting. No Officer shall make a report to a meeting for a decision to be made on any matter in which s/he has a financial interest.
- 2. A "financial interest" is defined as any interest affecting the financial position of the Officer, either to his/her benefit or to his/her detriment. It also includes an interest on the same basis for any member of the Officers family or a close friend and any company firm or business from which an Officer or a member of his/her family receives any remuneration. There is no financial interest for an Officer where a decision on a report affects all of the Officers of the Council or all of the officers in a Department or Service.

24 REPORT OF THE DIRECTOR OF PLACE 2015/2016 - REVENUE BUDGET (FOR INFORMATION ONLY)

K Collis presented the report of the Director of Place which gave details of the Joint Archive Service Revenue Budget for 2015/2016 and the reserves held by the Joint Archive Service, which was submitted for information only. The detailed budget was shown in Appendix A. It was noted that there were no additional savings for the Archive Service put forward for 2015/2016. The table in the report showed the estimated position of the Archive Reserves as at 31 March 2016. It was stated that the only expected use of the Training Reserve during 2015/2016 was in respect of the Archive Trainee post.

RESOLVED that the report be noted.

25 TO CONSIDER THE REPORT OF THE COUNTY ARCHIVIST.

K Collis presented a report which outlined the work of the Archive Service during the period December 2014 to February 2015.

Service Issue and Service Performance

The business plan for the Service during the period 2015 – 2017 was attached for information in Appendix 1. It was stated that it was not too late for members to submit comments on this action plan. The Chair suggested that any comments on the plan be submitted to the County Archivist by 31 March 2015.

The Committee were informed that discussions had taken place with the two major family history website companies regarding putting more digitised material from the archive collections online. This initiative had the potential to increase the existing income stream from the online parish registers. Questions were asked regarding the methodology to be used in deciding the successful bid.

Statistics for December 2014 to February 2015

Statistics for December 2014 to February 2015 were detailed in the report, which showed reductions across a number of performance indicators. The County Archivist detailed improved marketing of the schools education service had commenced. The Committee agreed that there was a need to be proactive and to emphasis the fact that there was no charge for the Archive Service to schools. It was queried how these figures compared to other local authority archive services in Wales and the Committee were assured that the number of visits to West Glamorgan Archives was the highest in Wales.

AGREED that a further report be submitted to the next meeting in June which would identify the initiatives that had been put in place to encourage greater usage.

Service Outreach

K Collis stated that the project outreach work of the Service in the last quarter had focused on 2 ongoing projects funding by external agencies, as detailed in the report. All Committee members were invited to a community event on Saturday 14 March 2015 at Sandfields Community Education Centre.

A comprehensive list of archives received during the period December 2014 to February 2015 was attached as Appendix 2.Following a recent incident it was stated that all schools in Neath Port Talbot had been contacted to be reminded that they should deposit their older records with the Archive Service and not allow them to pass out of local authority hands.

The Committee were informed by Mrs J L Watkins that a German author was producing a book on gas trams and that one chapter had been dedicated to the Neath Tram. It was queried if anyone knew of the whereabouts of a Neath Tram model.

The Chair thanked Canon Stephen Ryan who was attending his last meeting. He was thanked for his valuable contribution made over the last 13 years. He will be replaced by Charlotte Hodgson honorary Llandaff Diocesan Archivist.

Report of the County Archivist West Glamorgan Archives Committee 19 June 2015

The purpose of this report is to outline the work of the Archive Service during the period March to May 2015

1. Planning for the future

The Archive Service is in the initial stages of preparation for a period of profound transformation which will see the most significant alteration for more than two decades to the way in which the service is delivered. The current challenge is to understand and integrate each factor forcing change on the Archive Service and to produce a mutually agreed vision and forward plan which maintains service quality and is financially sustainable in the long term.

The factors necessitating change are threefold: impending Welsh local government reorganisation, the generic remodelling of the way local authority cultural services are delivered and the planned disposal of Swansea Civic Centre.

At the time of writing, it is anticipated that an announcement on the future shape of local government in Wales is imminent. This announcement will no doubt impact the two parent authorities and affect the future shape of the Archive Service. Independently of this process, the discussions referred to below point towards an agreement for joint service delivery with Carmarthenshire County Council as a serious option to be considered should other factors be favourable. This option would also align the service with UK and Welsh Government policy on archives to 'develop bigger and better services in partnership – working towards increased sustainability within the sector' ('Archives for the 21st Century' CM 7744).

Against this background, both Swansea and Neath Port Talbot Councils are looking at new models of delivering services through commissioning services and community involvement. Archives across the UK are involved in this process and some have already moved to trust status. A revision of the governance framework is a further factor to be considered once the future shape of the service is clearer.

Five bids have been shortlisted for the redevelopment of the St David's and Civic Centre sites in Swansea city centre and in-depth discussions with each of the shortlisted bidders are now taking place. The anticipated deadline for Council services to vacate Swansea Civic Centre is approximately five years, which gives a timeframe for the Archive Service to plan for its relocation of over 600m³ of historic records from the Swansea Civic Centre basement.

Two discussions have taken place during the quarter between Swansea University and Swansea, Neath Port Talbot and Carmarthenshire Councils to explore whether it is possible to develop together a shared vision for archive provision in south west Wales. These talks have been attended by Welsh Government and facilitated by an external consultant provided by the latter. Additionally, in early May, the group carried out a fact-finding tour of the Keep in Brighton, which is a joint archive facility for the University of Sussex, East Sussex and Brighton Councils.

2. Use of the Service

Statistics for March to May 2015

The number of members of public using the Service on-site, March to May 2015, was **1,751** and the total number reached by the Service on and off-site was **2,081**.

Following the March meeting, an investigation into the unexpected significant fall in use numbers at Neath revealed that a recording error had occurred and the correct figure for Neath to be recorded in the quarterly report should have been 423 not 283.

Using this revised figure, the annual figures for individual and group visits to Swansea and Neath were calculated for purposes of the 2014/15 annual report. They showed a 12% decline in individual visits at Swansea, a 22% decline at Neath, a 55% decline in on-site group visits and a 75% decline at Port Talbot (the last two elements having borne the brunt of the 2014 cuts).

Education Service

Members of staff have conducted one or several sessions with the following schools during the last quarter, delivered either on or off-site:

Birchgrove (x2) Clun Cwmglas Gwyrosydd Waunceirch

We have recently rationalised our offer to schools to make some of our less popular sessions into teachers' resource packs, concentrating the range of on and off-site sessions we offer on the most popularly requested subjects for Key Stages 2 and 3. Furthermore we have extended our range of Key Stage 3 sessions to include a session dealing with the Holocaust and German Jewish refugees in south Wales.

Commercial digitisation of the collections

The Service has now been visited by both of the major family history website companies, Ancestry and Find My Past, and is currently awaiting further detail from one of the companies before making a decision on which company to choose to pursue a commercial contract for online pay-per-view publishing of some of our records. Records which have been identified as name rich and therefore likely to be of interest to online family historians are historic electoral registers, ship's crew agreements, Poor Law records and prison registers. No financial outlay is required to pursue this project.

Fees and charges

Members are asked to approve the revised fees and charges table for 2015/16 attached at Appendix 1. Fees have been revised in line with market comparisons.

3. Service outreach

The outreach work of the Service is currently focused on three projects funded by external agencies, namely Welsh Government and the Heritage Lottery Fund. The two Welsh Government projects are funded by the 'Changing Cultures' grant scheme for archives, libraries and museums, which is aimed at addressing disparities in access to cultural provision for economically deprived communities in Wales.

The first project, in Sandfields Port Talbot was reported on in the last report to Committee. An event took place on 14 March at Sandfields Community Centre showcasing the children's exhibition about the history of the Sandfields estate which was attended by 29 local people. Subsequently the exhibition has been displayed in Port Talbot and Sandfield Libraries and has been well received. It is due to go back to Sandfields Comprehensive School for a special event and on to the Tata Steel Visitor Centre in July. A related exhibition incorporating some of the text and the work of the children is currently on display at the National Waterfront Museum.

A second similar project has been looking at the history of Townhill estate in Swansea and has involved two local primary schools. The exhibition is currently being printed and will be displayed in the Phoenix Centre Townhill and other Swansea venues this summer.

Funded by the Heritage Lottery Fund, the project 'Cynefin: Mapping Wales' Sense of Place' is a three-year project to digitise the tithe maps of Wales which is now at its halfway point. The Archive Service is involved in both the overall project and one of six local projects across Wales, 'Exploring Gower's Ancient Woodland'. There has been significant volunteer activity on this local project during the last quarter from a range of individuals and environmental groups, with some press publicity about our activities.

As referred to above, the Archive Service 2014/15 annual report was published in May, with a mixture of information about the Service's activities and local history articles by staff and guest authors relating to newly-acquired collections. The publication is nowadays only available online and, by adopting a magazine approach, is aimed at a wider and more general readership than its previous hard copy version.
