Minutes of the West Glamorgan Archives Committee (15.12.2017) Cont'd

13 Matters Arising.

The County Archivist and Andrew Dulley reported further to the query raised at the last meeting and updated the Committee on the initial research they had undertaken regarding the possible establishment of a separate Archive Service website.

They detailed the potential options and basic costings for the setting up a dedicated website or a separate area where larger documents could be stored and accessed via the current Archive Service page on the CCS website.

The Committee discussed the merits of the two options going forward, the budget implications, technical issues, potential income streams and requested a written report to the next meeting.

14 Report of the County Archivist.

The County Archivist presented a report which outlined the work of the Joint Archive Service during the period September to November 2017.

Use of the Service

He reported on the use of the Service for the quarter and detailed the background behind the quarterly statistics.

He detailed and outlined the figures for the number of hits to the Archive Service webpages and to Archive Service content on the Ancestry website.

Exhibitions and Events

He reported that the 'Our Abertawe: Celebrating Swansea Together' exhibition went on display at the National Waterfront Museum in November. The exhibition will also form part of a wider multicultural programme theme at Swansea Museum next year.

He referred to the preparatory work being undertaken with regard to a project to celebrate the 100th anniversary of women's suffrage, and detailed the links developed with Women's Wales Archives and Women's Local Government Society on this project. He indicated that in an era of budgetary pressure, he valued the Service's partnership working and would continue to work with other Council sections voluntary groups and with Communities First co-ordinators in both Authority areas.

He outlined the various events and fairs the Service attended by the service during the period.

The Chair referred to three events taking place next year that the Service could be potentially involved in, including the centenary of the end of the First World War, and the establishment of both the Order of St John and the Royal Air Force.

Minutes of the West Glamorgan Archives Committee (15.12.2017)

The County Archivist outlined the various talks given to schools during the period, and the Service's use of social media for involvement in initiatives such as National Map Reading Week and the UK-wide 'Explore your Archive' campaign.

He also referred to the Service's recent advertising on Facebook and outlined its relative success.

Digital Preservation Policy

He referred to the draft policy which all public authorities across Wales are looking to adopt to ensure a co-ordinated approach across Wales in this complex and expanding area, and referred to the key mission statement outlined at para 4.4 in the policy.

He indicated that it is likely that all Authorities across Wales and not just archive services will need to adopt the policy in the future, particularly given the move away from paper to 'born digital' records. These are records which never exist in hard copy.

Resolved that the policy be approved and adopted.

Professional Meetings and Partnership Working

He reported on the various professional meetings attended by staff during the quarter.

Training

He outlined the various training courses attended by staff during the guarter.

Archive Collections

He reported on the list of archives received by the Service during the quarter.

1.0 Introduction

- 1.1 The Archive Service is jointly funded by both the City and County of Swansea (CCS) and Neath Port Talbot County Borough Council (NPTCBC). Each authority is responsible for agreeing their level of contribution as part of their respective budget processes, always in the ratio of 68% (CCS) and 32% (NPTCBC).
- 1.2 This report includes the detailed 2018/2019 budget, shows the required contributions agreed by each Authority and lists the expected balances on reserves.

2.0 Revenue Budget 2018/19

- 2.1 The budget for 2018/19 is expected to be £282,800, compared with the 2017/18 budget of £272,300. In line with the City and County of Swansea's budget assumptions a 2% pay award which covers 2018/2019 has been included and uplift has been applied for the increase in employers pension fund contributions, but no other price increases have been assumed. The detailed budget is shown in Appendix A.
- 2.2 The increase of £10,500 is mainly as a result of the pay award and pension contributions. This is offset against one minor adjustment to insurance budgets and a small increase in fees and charges and sales income as part of savings.
- 2.3 The required contributions from the two partners are:

The purpose of this report is to outline the work of the Archive Service during the period December 2017 to February 2018

1. Briefing note on the potential for the Archive Service to develop a separate website

Following a request by Members at the last meeting, a briefing note is attached at Appendix 1 which provides more information on the pros and cons of the Archive Service establishing its own website. As any decision to change would represent an operational decision by the Service, this is provided for information only. There are capital and revenue implications in any decision to change the current hosting arrangement which are quantified in the note.

4. Service outreach

Exhibitions and events

Archives staff created an exhibition on Edwardian Swansea which was displayed in the Swansea Civic Centre foyer during December and January.

The Service was successful in its application for Welsh Government funding to create an exhibition on the theme of the women's suffrage centenary, the application being reported on at the last meeting. The grant will cover two linked portable exhibitions on the theme, one for adults and one for children, together with an accompanying film to be created by students from the University of Wales Trinity St David. On February 6th (the centenary of the Bill's Royal Assent) the Women's Local Government Society announced that Winifred Coombe Tennant and Emily Phipps were on its national list of 100 suffrage pioneers. The two suffrage campaigners had been nominated by the Archive Service and the Women's Archive of Wales respectively.

Work has been undertaken by the National Library of Wales to digitise sixty-six engineering drawings from the Neath Abbey Ironworks collection, which will be published online by People's Collection Wales. The work has been made possible by a grant from the Friends of the National Libraries, who helped to fund the purchase of the collection in 2013. It is anticipated that the online resource will help raise the profile of the collection, the Neath Abbey Ironworks and Wales' contribution to the Industrial Revolution.

Briefing Note On The Development Of A Separate Archive Service Website

Members asked at the last meeting of the Archives Committee for further information on the implications of developing a separate website for the Service. While this would be an operational decision for the Service to take, there is value in openly quantifying here the costs and benefits of such a move in order to justify and support an informed decision.

The conclusion of this exercise as outlined below is that any change from the status quo would provide limited benefits for the increased cost involved and would conflict with Swansea Council's policy on independent website development.

A more appropriate use of scarce resources may be on further development of the Service's use of social media which targets a younger audience and accords with our audience development plan.

Advantages

The website would be able to take more digital content, free-to-view or pay-on-demand, since it would have more server space available, albeit at a cost.

The archive catalogues could be made available in a more browsable form.

The Archive Service would not be tied to the website of either parent authority and could develop an identity of its own.

Disadvantages

It would cost approximately £3,000-£5,000 to set up, including purchase of domain name, artwork and branding, technical development, the initial requirement to market the site and capital costs re server space.

It would cost around £300 to £500 per annum to maintain, including the rental of separate server space, software annual costs, updates and domain name licensing.

Extra staff resource would be required to maintain the site.

As a separate website, without careful branding and artwork, it may appear as if the website was not official or the Archive Service was not a Council service.

There could be a problem with search engine results without search engine optimisation work.

Creation of a separate website would contradict Swansea Council policy.

Technical assistance would be needed to ensure that search engine results continued to point to the site and was on hand if the website crashed. As described above, the website would be have to be developed in contradiction to Swansea Council policy, therefore technical support would not be available from Swansea Council.
