11 OVERVIEW OF CITY DEAL. (PRESENTATION - PHIL HOLMES).

The Head of Planning & City Regeneration gave a comprehensive overview presentation to the Committee on the Swansea Bay City Region Deal.

- Funding breakdown and investment from both City Deal money and private industry investment for each scheme was outlined;
- Proposed returns for the investment, and aims and objectives of projects
- Front loading of Local Authority monies to kick start projects;
