#### 74 Town Police Clauses Act 1847 and Local Government (Miscellaneous Provisions) Act 1976 - Equality Act 2010 - Passengers in Wheelchairs -Request for an Exemption Certificate - DAC.

The Divisional Officer, Licensing, Food & Safety, detailed the background in respect of DAC's request for an exemption certificate.

DAC explained the circumstances relating to the request and answered Members' questions.

**Resolved** that DAC's request for an exemption from carrying wheelchair users in a hackney carriage vehicle and or private hire vehicle be **approved until 30 November, 2018.** 

#### 75 Town Police Clauses Act 1847 - Local Government (Miscellaneous Provisions) Act 1976 - Equality Act 2010 - Passengers in Wheelchairs - Request for an Exemption Certificate - MJP.

#### 76 Town Police Clauses Act 1847 - Local Government (Miscellaneous Provisions) Act 1976 - Application for the Grant of a Restricted Hackney Carriage and Private Hire Driver's Licence - AGB.

The Divisional Officer, Licensing, Food & Safety, detailed the background in respect of AGB's request for the grant of a restricted hackney carriage and private hire driver's licence.

AGB explained the circumstances relating to his application and answered Members' questions.

**Resolved** that AGB's request for the grant of a restricted hackney carriage and private hire driver's licence be **refused**.

#### Reason for Decision

Members were not satisfied that AGB was a fit and proper person for the following reasons:

- 1. Failure to disclose an offence;
- 2. AGB was still subject to three monthly medical reviews and there was evidence to support his claims that he has recovered; and
- 3. The impact of the medication on AGB's ability to drive safely.
