Flying Start Capital Bid 2019/20

Purpose:	To outline the capital proposal included in the Capital Funding Application submitted to Welsh Government in respect of the Flying Start Programme 2019/20.
Policy Framework:	One Swansea Plan

1. Introduction

- 1.1 Flying Start is one of the Welsh Government's (WG) Flagship Programmes aimed at improving outcomes for children under 4 in the identified most deprived areas with the main focus of child development.
- 1.2 Swansea's model of delivery for the Flying Start Programme has been acknowledged by Welsh Government (WG) as good practice. Flying Start settings are sited at Primary Schools ensuring the use of available space (potential surplus capacity) to establish "mini children's centres". These comprise of the required Care Inspectorate Wales (CIW) registered

Childcare Facility; provide a base for Health Visitors and Parenting and Early Language Development provision. This has enabled co-located multi-agency teams to operate to support young children and their families in each area.

- 1.3 The Flying Start Programme in Swansea has been developed with the aspirations for 21st Century schools so that the benefits of Flying Start are maximised within Primary Schools and Community Focussed Schools. This also provides the opportunity to achieve effective transition into the Foundation Phase.
- 1.4 There have been 3 main phases to the rollout of the Flying Start Programme. During 2013/14 the CAP for the programme in Swansea was 1438 0-3 year olds. At the end of 2014/15 part way through the second phase, there were 2659 0-3 year olds in the Flying Start Programme in Swansea benefiting from the full range of entitlements across different settings. In 2015/16 the full approved Programme was established with a CAP number of 2,903 0-3 year olds annually

2. 2019/20 Capital Bidding Round

- 2.1 WG has asked Local Authorities to bid for additional capital funding to help maintain the standards of provision for existing Flying Start settings. They have advised that this request does not represent a commitment that funding is available this financial year, and authorities are not invited to submit bids to increase or expand Flying Start provision at this time. The main focus of the funding is to address business continuity and health and safety issues.
- 2.2 A bid of £104,000 to address business continuity and health and safety areas at the existing settings Flying Start settings has been submitted with the following breakdown of works.

3. Equality and Engagement Implications

- 3.1 The Council is subject to the Public Sector Equality Duty (Wales) and must, in the exercise of their functions, have due regard to the need to:

- 3.2 Our Equality Impact Assessment (EIA) process ensures that we have paid due regard to the above.
- 3.3 An EIA screening has been undertaken and it has been determined that the initiative is not relevant for a full EIA report.
- 3.4 As part of this process we will also be considering the Well-being of Future Generations Act. The Act ensures that public bodies think more about the long term, work better with people and communities and each other, look to prevent problems and take a more joined-up approach.

- 3.5 All key stakeholders will be communicated with throughout the projects' delivery.

4. Financial Implications

Capital

- 4.1 The total cost of the capital improvement works if approved is £104,000 if the bid is approved in its entirety. There is no commitment from WG that any capital will be available.
- 4.2 The funding relates to the period April 2019 to March 2020 and must be claimed in full by 31 March 2020 otherwise any unclaimed part of the funding will cease to be available to the Council. The funding available has been profiled as set out in Appendix A.

Revenue

- 4.3 Flying Start revenue funding has already been committed. There will be no additional recurring revenue costs as a result of this bid.

5. Legal Implications

- 5.1 In line with arrangements at all other school based Flying Start settings a licence agreement is in place to ensure clarity of roles and responsibilities relating to the asset.
- 5.2 If approved, the grant offer from WG will contain conditions which are legally binding. The Council must be satisfied that it is able to comply with the same.

1. Introduction

- 1.1 The purpose of this paper is to provide an overview of the award of grant funding to support the reduction of the number of children entering care.

2. The Grant

- 2.1 Welsh Government awarded this grant directly and did not require an application from the Council. Allocations have been offered to all Welsh Councils in recognition of the financial pressures faced by Councils as they seek to manage escalating demand for statutory Child and Family Services. The offer to this Council is for £76,620 and is to be paid out within the 2018/19 financial year.

2.2 The purpose of the funding is to help local authorities reduce the need for children to enter care and pump prime activity that will be undertaken in 2019-20.

2.3 The Cabinet Member has been informed and consulted. Due to the short timescales for acceptance imposed by Welsh Government, this report is provided to Members for their information.

3. Equality and Engagement Implications

3.1 There are no equality or engagement implications associated with this report. An Equality Impact Assessment screening form will need to be completed when considering how the grant funds are to be used.

4.1 This funding will help support the Council's financial commitments in this key area.
