1 Welcome/Thanks.

The Chair welcomed Councillor Jen Raynor back onto the Committee and thanked Councillor Mike Durke who she was replacing for his contribution over the years.

4 Matters Arising

The County Archivist reported that the staff structure remains unchanged for the moment, but Covid and the potential new facility provide an opportunity to review and revise provision going forward.

He indicated that the actual physical unveiling of the blue plaque to the anti-slavery campaigner and activist, Jessie Donaldson had to be postponed in the pre election period and will now take place on June 19th

5 Report of the County Archivist.

The County Archivist presented a report which outlined the work of the Joint Archive Service during the period March 2021 – May 2021.

COVID-19 Pandemic

He indicated that the Swansea searchroom reopened to the public on Tuesday 6 April on an appointment-only basis, following the easing of restrictions imposed by the latest national lockdown.

He outlined that he hoped to open the Family History Centre as soon as the relevant restrictions are eased and allow this to happen.

He indicated that there is no date yet, to reopen the facility at the Mechanics Institute in Neath, but reported that discussions with Neath Port Talbot Council and Neath Antiquarian Society remain ongoing.

Outreach and Educational Activity

He stated that all outreach work during the quarter remains limited by the lockdown and of necessity has been confined to online engagement with our users and social media followers. We continue to engage with schoolteachers remotely and provide online educational resources for, mainly, primary schools.

The Service also continues to promote itself via the social media platforms of Facebook and Twitter and has more recently added the medium of Microsoft Teams as a means to deliver online lectures and family history advice.

The online talks given during the quarter remain popular with the public.

He referred to the publication of the service's annual report which can be found at Swansea - Annual Report of the County Archivist.

Members of the committee supported and commended the contents of report and welcomed the diverse mix of articles contained within it.

He indicated that the project on the history of Wales' connection with the historic slave trade has grown during the last quarter and now encompasses almost all Welsh local archives together with Bangor, Swansea and Cardiff Universities. Very

positive feedback has been received from the working group set up to review the Wales Curriculum with regard to this subject and the project is making steady progress.

Former British Home Stores Building

He reported further to the update given at the March meeting and stated that Swansea Council has appointed Coreus Group to head a Multi-Disciplinary Team (MDT) to develop the City Centre Community Hub project planned for 277-278 Oxford Street.

Amongst other tasks, the MDT will investigate whether a part of the building is capable of conversion to an archive repository which will meet British Standard 16893. The County Archivist has attended an initial exploratory meeting with the architect engaged by the Coreus Group, Neil Farquhar of Austin-Smith Lord Architects of Cardiff. A report on the suitability of the building for housing the archive will be issued in due course and the County Archivist will continue to liaise with the MDT to achieve this goal.

He outlined the importance of any new facility achieving the BS 16893 standard for archives. Members of the committee supported the need for any new facility to achieve the necessary BS standard.

Use of the Service

He indicated that the figures relating the use of the service reflect the effect of the pandemic.

Talks and Professional Meetings

He reported on the various meetings attended by staff during the quarter.

Archive Collections

He reported on the list of archives received by the Service during the quarter.

Report of the County Archivist

The purpose of this report is to outline the work of the Archive Service during the period June to August 2021

1. The COVID-19 pandemic and service suspension

The Archive Service has continued to operate a limited service in its Swansea service point during the last quarter, providing access to original documents which are prebooked by the researcher. Following a revision of the service's COVID risk assessment, the Archives shop and Family History Centre re-opened on 27 July, providing an extra four seats for customers on top of the four already provided in the archive searchroom.

Swansea Civic Centre at the same time re-opened for casual visitors, a consequence being that if the Archives is able to accommodate a casual visitor it will do so rather than turn them away. All the above constitutes a significant step towards restoring a normal level of service for our customers, although occupancy of the public space is limited by the need to maintain social distance. A number of casual visitors have already been in to view the full version of the current electoral register, which is only available in the archives and to which we provide a statutory right of public access.

No discussions have taken place as yet as to the re-opening of the Neath service point. This can only take place once a new member of paraprofessional staff is in place and a full COVID risk assessment of the Mechanics Institute building has been undertaken.

2. Potential relocation of the archives to the proposed City Centre Hub

The City Centre Hub project has now completed RIBA Stage 2. However, no decision has as yet been taken whether the Archives will be part of the project or not, which is still at the stage of a feasibility study.

While there are undoubted benefits to the inclusion of the Service in the project in terms of service delivery (in both the central location of the building for our customers and a proposed co-location with Swansea Central Library Local Studies section) the

key question revolves around whether it is possible to integrate a secure archive storage area into the multi-use building, one which will meet British Standard 16893, Specifications for location, construction and modification of buildings or rooms intended for the storage or use of heritage collections.

In very brief summary, the key elements of BS 16893 can be classed as follows:

- A fire risk strategy which provides for four-hour fire resistance for all elements of the storage area;
- A security risk strategy which includes a minimum of Class 4 resistance for the outer walls and doors of the storage area (i.e. attempted penetration by intruders using heavy-duty tools);
- An environmental risk strategy which includes thermal stability of less than 1 C variation in any 24 hour period.

Advice on the requirements of any archive building conversion work continues to be provided by the National Conservation Service as part of the Archive Service's subscription to the scheme.

3. Outreach and educational activity

It has not been possible because of the pandemic to programme any outreach activity during the last quarter, a period which is always slack because of the school holidays. Activity via the social media vehicles of Twitter and Facebook continues on a regular basis.

The project regarding sources for the history of Wales' connection with the historic slave trade continues to advance slowly, with a planned pilot study to take place with Swansea secondary school teachers in the autumn. At the same time, archivists and museum managers across Wales have put forward a project proposal to Welsh Government relating to the discovery and re-interpretation of our catalogues to incorporate greater recognition of sources for the history of our BAME communities. The Archive Service has signed up to be part of this, which will hopefully not affect funding for the first-mentioned project which is more narrowly focused on the historic slave trade. A decision on funding is awaited.
