## **10 Disclosures of Personal and Prejudicial Interests.**

In accordance with the Code of Conduct adopted by both Authorities, no interests were declared.

## **11 Minutes.**

**Resolved** that the Minutes of the West Glamorgan Archives Committee meeting held on 10 September 2021 be approved as a correct record.

## **12 Report of the County Archivist.**

The County Archivist presented a report which outlined the work of the Joint Archive Service during the period September 2021 – November 2021.

### Covid-19

He indicated that the Swansea searchroom remains open to the public, and is used regularly but on a much reduced basis due to the number restrictions on visitors due to the pandemic.

He reported that discussions had been undertaken with Neath Port Talbot Council and the Neath Antiquarian Society and a health and safety assessment undertaken with a view to reopening the facility at the Mechanics Institute in Neath, but indicated that at present the Antiquarian Society were unfortunately unable to commit to assisting at this time. The situation would be reviewed again in the New Year.

#### Archive Service Accreditation

He reported that following the annual review of its accreditation the service had been awarded provisional status until November 2022.

#### Outreach and Educational Work

He indicated that the school service had restarted during the quarter via Microsoft Teams, which could be a basis for delivery going forward.

The project on the history of Wales' connection with the slave trade remains ongoing, with the pandemic impacting on the progress and review of the programme in schools.

#### Use of the Service

He indicated that the figures relating the use of the service reflect the effect of the pandemic.

#### Talks and Professional Meetings

He reported on the various meetings attended by staff during the quarter.

#### Archive Collections

He reported on the list of archives received by the Service during the quarter.

#### Potential Relocation of the Archives Service to the Proposed City Centre Hub

He then gave a detailed and lengthy verbal presentation and outlined the contents of a 'technical note' he had prepared relating to the proposals for the proposed relocation of the Archives service to the new city centre hub. The details of the proposals are contained in a confidential report which would be considered by Cabinet in Swansea on 16<sup>th</sup> December 2021.

He also displayed several plans to the committee which outlined the proposed layout of the new building and size of the new Archives facilities relating to both the public facing side of the building and the storage facilities which would be situated on the second floor of the new building, and their comparisons with the existing provision in the Civic Centre.

The presentation followed on from an informal presentation on the proposals from the multi-disciplinary team (MDT) in Swansea Council to Archives Committee members in November.

Covered during the presentation in detail were external advice and information relating to various issues including BSI standards, fire safety, security and thermal modelling. It was outlined that the proposed public searchroom would be considerably smaller than the current one, with no separate family history provision for the public, however this was still subject to change. There would however be a separate "education room" for the building which could be utilised.

He outlined that he would circulate the technical note, plans and advice on fire, security and thermal modelling etc following the meeting.

Members discussed the proposals and issues raised at length and asked numerous questions of the County Archivist who responded accordingly. They also queried and raised concerns on whether the plans were the most up to date and latest ones, as the cabinet report seemed to indicate that they weren't. Queries were also raised on the size of the strongroom, particularly if as indicated in the cabinet report the service takes on additional collections. They also queried whether Neath Port Talbot Council would be able to comment on the proposals as partners to the joint service.

It was outlined that the Scrutiny Programme Committee in Swansea would be examining and discussing the report at their meeting on Tuesday 14<sup>th</sup> December, with the Chair of that Committee giving feedback to the meeting of Cabinet on the 16<sup>th</sup> December.

(Note: Cllr Robert Smith remained to hear the debate and asked questions but did not declare an opinion relating to this item)

### 2022/2023 Revenue Budget

#### 1.0 Introduction

- 1.1 The Archive Service is jointly funded by both the City and County of Swansea (CCS) and Neath Port Talbot County Borough Council (NPTCBC). Each Authority is responsible for agreeing their level of contribution as part of their respective budget processes, always in the ratio of 68% (CCS) and 32% (NPTCBC).
- 1.2 This report includes the detailed 2022/2023 budget, shows the required contributions agreed by each Authority and lists the expected balances on reserves.

#### 2.0 Revenue Budget 2022/23

- 2.1 The budget for 2022/23 is expected to be £311,150, compared with the 2021/22 budget of £299,550. In line with the City and County of Swansea's budget assumptions an approximate increase for the Pay Award of 3% has been included. No other price increases have been assumed. 2.2 The increase of £11,600 is as a result of the Pay Award £11,800. This is offset against a small increase reduction in employee and premises insurance of £200. The detailed budget is shown in Appendix A.

## 1. Service point reopening

The service has continued to run in Swansea Civic Centre with the limited Covid risk-assessed service described in last quarter's report. The Neath service point remains closed but is looking to reopen imminently under the terms of a COVID risk-assessment which is currently under preparation.

To explain some of the collaborative projects listed above:

The National Broadcast Archive project will see the Archives become an access point for the archives of several Welsh television companies (BBC, S4C and HTV) via the National Library of Wales. It is anticipated this facility will open in the spring or early summer in the Family History Centre as one of a dozen such service points.

The World Re-imagined is a project providing an artistic response to the historic transatlantic slave trade and our continuing connection to its legacy. Ten globes will be placed along a trail around Swansea city centre, each one connecting to a project theme. A number of episodes from history, objects from heritage collections, and oral histories from the community, will be recorded/captured digitally and made available on the TWR website.

The Welsh Vital Digital Records Working Group is looking to find a solution to the long-term preservation of born-digital records created by councils across Wales. Typically these records at risk are the records of Social Services departments (of child adoption in particular), however a long-term solution for council minutes is also needed, presuming that at some point in the future the website *modern.gov.uk* will want to delete its older records.

### 5. Potential relocation of the archives to the proposed City Centre Hub

A decision in principle to relocate the archives to the City Centre Hub was taken by Swansea Council's Cabinet in December. It remains critical that British Standard for archival storage is met, which at this stage Swansea Council and the design team believe can be achieved, however some of the detail relating to security is partly dependent on the allocation of space between the building's stakeholders when the project completes RIBA stage 3. Conformity with the British Standard in turn affects the ability of the Service to meet the Archives

Accreditation Standard and its status of recognition by The National Archives Kew as a local Place of Deposit for public records.

Whilst Swansea Council and the appointed design team believe that the proposed scheme will be able to provide adequate facilities for the archive collections, the decision as to whether the proposed scheme is the right long-term solution for these collections in terms of collections development will be determined by an archives sub-group of the Hub Project Team in the coming months. Alongside the decision to proceed, and bearing in mind the broadening of the project to include other heritage collections, it has been agreed to also seek external funding to investigate the feasibility of a more sustainable long-term solution to the needs of these collections in the form of a dedicated history centre in Swansea city centre.

Assuming several heritage services are to be accommodated in the City Centre Hub, this move would then serve as a first phase which could lead into a second phase where Swansea Council would seek to work with those stakeholders and partners to provide a home for several heritage collections, freeing the former BHS building from a dual role as both a heritage store and a community hub.

Intended at this early stage to be an adjunct to Swansea Museum, the history centre feasibility study will look at the opportunities for mutual collaboration with the Museum that such a project might bring, including archival quality storage for the Museum's works on paper and its other delicate items; shared high-quality education facilities which the Museum sadly lacks at the moment; and a temporary exhibition space built to British Museum standard which would not only allow for the display of archives and other light-sensitive materials but also allow Swansea Museum to receive loans of items from the national collections in prestige exhibitions. This history centre could be a cultural attraction of benefit to the sector more widely, adding to the visitor footfall and tourist appeal of Swansea's Museum quarter.

## 6. Fees and charges for 2022/23

A table of fees and charges is attached at Appendix 1 with a stand-still from 2021/22. Income is still considerably reduced due to the lack of economic activity and footfall in the service points, furthermore it is recognised that most of our service users are facing considerable cost of living pressures. **Members are asked to approve the table of fees and charges attached at Appendix 1.**
