Section 1: Constituency activities

Have delivered to all residents three non-political newsletters (4 sheets A4) (July and November 2012 and April 2014) giving updates on all issues that I deal with as ward member. I do not hold surgeries because I prefer to respond immediately to any matter of concern to a resident and I normally visit within hours of a phone call or e-mail. I've completed a large number of forms for constituents, have written letters on their behalf, several to utility companies, attended a tribunal in support of one resident and am in very frequent contact by e-mail with the Council's Housing officers in Gorseinon and Coastal Housing in regard to numerous housing problems. I've also held several meetings with officers from Highway's and Parks, I've attended PACT meetings and also police meetings held in Gorseinon. I've regularly litter picked, have washed dirty road signs and cut back vegetation causing a nuisance on Highways land.

I was very active in ensuring that Parc Penllergaer became an adopted development which was achieved at the end of October 2013.

I was part of the team that put on a very successful Community Fun Day in early July 2013 to celebrate St. David's church 175th anniversary, I and a friend held a charity 'Open Gardens' in late July 2013 (an annual event) raising over a £1000 for the 'Forget Me Not Clubs' and two active groups I helped set up -Icers and Crafters- ran charity events last Christmas and Easter raising nearly £1,100 for Marie Cure and Cystic Fibrosis.

I'm a Community Councillor and board member of the Penllegare Trust, a member of Penllergaer Ladies Guild and of Penllergaer Gardening Club.
