Gypsy/Traveller Sites - As a result of an information letter I produced and delivered to every household within Gorseinon, I was pleased to see over 1000 residents come together at Gorseinon Workingman's Club to debate the possibility of a Gypsy/Traveller site being potentially located in the town. The meetings provided an opportunity for the people of Gorseinon to present their views and I was pleased to see community leaders get involved too.

Gorseinon Events - I am a supporter of Gorseinon's 3 major events – Gorseinon Christmas Parade, Gorseinon Carnival and Gorseinon Food Festival. These annual events cover winter, spring and summer and provide a huge boost to the town and help to keep community spirit strong. I am extremely proud of all the people involved, who give many hours of their time to ensure that the events continue to be a success.

Bryngwyn Estate - I have been working with residents and Persimmon to ensure that all issues are addressed before Persimmon move off site this year.

Building and Improving Strong Relationships - I have been working to ensure that strong relationships are built and held with Swansea Council, Gorseinon Town Council, Gorseinon Chamber of Trade and Gorseinon Development Trust.

Working together with the Police - I meet regularly with our PCSOs and meet Quarterly with the Police inspector for Gorseinon.

Gorseinon Primary School - I have been working to arrange for the School Council to visit the Guildhall in Swansea for a 'mini-debate' and tour. I am also continuing my campaign to secure a new Primary School for Gorseinon.

Gorseinon Youth Club - I have recently visited the Club and continue to be very impressed by the fantastic facility. We are going to start holding meetings that effect the youth at this facility, to help them to become more involved with the decision making.

Gorseinon Parks - Initiatives I have been involved with this year include, helping to secure funding for a skateboard park somewhere within the Town and Exercise Equipment at Parc y Werin. I also took part in Parc Melin Mynach Litter Pick. New Equipment at Parc y Werin will be installed August this year.

Asda Petrol Station - I am in the process of meeting with managers to ensure that nearby residents face the minimum of disruption when this petrol station is built. Plus I hope to secure some improvements to the nearby area.

Gorseinon Gateway Monday Club - I continue to support this charity and have helped to secure a much needed grant this year.
