Section 1: Constituency activities

Together with the other Castle Ward Councillors, I attended the weekly surgeries held on Saturday mornings in Brynmelin, Marina, Sandfields and Dyfatty. Additionally I attended Brynmelin/Waun Wen, Mount Pleasant, Marina & Sandfields Residents & PACT meetings.

I responded and dealt with a number of residents' issues including complaints about waste, parking, cleansing, anti-social behaviour, transport, highways etc.

I was, and remain a Governor of Terrace Rd school. I attended meetings of the District Housing Office to hear about tenant issues

With ward colleagues we were successful in getting new play equipment for Bryn Y Don Park and setting up a Friends of Bryn Y Don Park group. We were involved in organising and taking part in bulb planting, a litter pick and other activities.

I enabled the installation of a gate in Dyfatty Park allowing the pupils of Ysgol Crug Las to access Dyfatty Park in greater safety

I took and continue to take, a keen interest in the Vetch Veg Community Garden and have attended numerous events including visits by a range of organisations and government ministers.

I was involved in the meetings and discussions around the Sandfields Neighbourhood Renewal Area – a scheme which we hope will be delivered from 2014.

I have taken a keen interest in planning matters related to my ward.

I have taken special interest in the issues around the Palace Theatre and attempting to get the owners to deal with the serious dilapidation of the structure. Progress is being made with an agreement recently signed between CCS and the owners.

Attended a large number of meetings of Communities First – with Castle ward being in 2 cluster areas (South – Sandfields & North West – Waun Wen/Brynmelin). I have met with police and PCSOs to discuss issues around licensing activity, substance misuse and antisocial behaviour.

Section 3: Councillors role and responsibilities

This portfolio is very broad in its remit covering the 3 "pillars" of sustainability – economic, social and environmental. The introduction of the Sustainable Development Bill in 2014 (now the Future Generations Bill) requires all public bodies to make sustainability a central organising principle. CCS is a lead local authority (an "early adopter") in Wales for Sustainable Development and as the only Cabinet Member in Wales with this portfolio I have attended numerous meetings and given presentations to other local authorities across Wales on our practice and policy development in Swansea.

I have taken a lead on:

- Developing renewable energy projects in the city: (Community Renewable Energy Enterprise Scheme & District Heating)
- Developing new initiatives around community growing;
- Issues affecting community cohesion and safety (see below)
- Becoming a Sustainable Food City
- Joining the Council to the LGA Climate Local scheme
- Developing a new Master Plan for the Vetch Field site as a model of sustainable development

I was and still am the Biodiversity Champion and have promoted good practice such as managing verge cutting etc to promote pollinators.

I also chaired an officer/councillor Task & Finish Group compiling evidence on the impact of HMO density on community sustainability, street scene and anti-social behaviour. This evidence was submitted to Welsh Government with a view to getting a change in the "Use Class Order" such that all HMO's regardless of size – within areas of density would require planning permission.
