Together with the other Castle Ward Councillors, I attended the weekly surgeries held on Saturday mornings in Brynmelin, Marina, Sandfields and Dyfatty. Additionally I attended Brynmelin/Waun Wen, Mount Pleasant, Marina & Sandfields Residents & PACT (Police & Communities Together) meetings.

I responded and dealt with a large number of residents' issues including complaints about waste, parking, cleansing, anti-social behaviour, transport, traffic, highways etc.

I was, and remain a Governor of Terrace Rd school. I attended meetings of the District Housing Office to hear about tenant issues.

I attended meetings in regards to the Sandfields Housing Renewal Area.

I took and continue to take, great interest in the Vetch Veg Community Garden which brings together a wide range of people from across the Sandfields.

I have taken a keen interest in planning matters related to my ward.

Attended meetings of Communities First – with Castle ward being in 2 cluster areas (South – Sandfields & North West – Waun Wen/Brynmelin). I have met with police and PCSOs (Police Community Support Officers) to discuss issues around licensing activity, substance misuse and anti-social behaviour.

### Section 4: Initiatives and Special activities

As Cabinet Member for Sustainability I continued to champion the development of both the District Heating Scheme and the progression of my own initiative to develop a Community Renewable Energy and Enterprise Scheme (CREES) involving PV on community buildings in Target Areas and scoping a bigger scheme to put PV on council owned residential properties with a view to developing local skills, alleviating fuel poverty etc. I took a keen interest in developing cycling routes and facilities, meeting on a regular basis with Swansea Wheelwrights organisation and liaising with Sustrans.

I continued to press for action requiring organisations dealing with substance misuse to employ a community liaison officer to deal with the impact of such premises on local residents.

I continued to champion work I had initiated in regard to community growing schemes to assist people in deprived areas to grow food and eat healthily. I chaired meetings of the Grow Local panel allocating small grants to community groups and schools.

I chaired an initiative involving arts organisations with a view to develop cultural activity to support the Purple Flag initiative.

I continued to press for a change in Use Class Orders to bring all HMOs (Houses in Multiple Occupation) into the planning regime with a view to controlling density and quality and I met with the Minister responsible in Welsh Government.

I chaired the Sustainable Development group - Welsh Local Government Association (WLGA) & City & County of Swansea (CCS) and attended a number of events including the launch the launch of the Future Generations "Generation 2050" report.

I launched the CCS Guides to Community Growing which I had initiated in my Cabinet role.

As a ward councillor and with ward colleagues we were successful in setting up a Friends of Bryn Y Don Park group. We were involved in organising and taking part in a range of activities for young people including barbecues and stargazing.

I met with officers of the Sandfields Residents Association to support them in seeking to retain the whole of the Vetch Field for community recreation and celebrations.

I met with officers and the Cabinet Member to press for improvements to green space as part of the refurbishment programme for Croft Street flats.

I continued to press for improvements in green space for city centre residents and in particular recreation space – Fields in Trust (FIT).
