Several ward initiatives were carried out in the last year at the request of residents. These included:-

The development of a skate park in Maesteg Park and an upgrade of the play facilities in Maesteg Park.

A fenced off picnic area by the Ashlands Community Centre in Port Tennant (thanks to the NEAT team).

Regular clearance of the lanes across the ward.

More dog fouling notices, bins and patrols.

An extensive review of residents' parking in several streets across the ward and the introduction of 20mph zones.

We also saw a 'living barrier' installed on Fabian Way, a notorious motorway separating St Thomas from SA1. The living barrier is an attempt to prohibit pedestrians from crossing Fabian Way in the wrong places and putting themselves and motorists in danger.

Heavily involved in the Communities First Project and the continued support for local job creation and the development of the Swansea Tidal Lagoon.
