## **Section 1: Constituency activities**

New Psychoactive Substances (NPS ) – aka "Legal Highs"

As you know over the past 18 months we have experienced problems in Swansea regarding the supply of NPS to our young, vulnerable people causing issues of anti-social behaviour and serious concerns for their health and safety.

This past year I have been extremely proactive in my role as a Councillor in trying to tackle the menace of NPS.

I played a significant role in constructing the Notice of Motion to Council in November 2014 calling upon Central Government to introduce a blanket ban to prevent the sale and distribution of these very dangerous substances. We were the first Local Authority in the UK to do so. The Notice of Motion also highlighted our concerns as a Local Authority to Welsh Government regarding the detrimental impact of these toxic products.

I have worked closely with South Wales Police and our Trading Standards Team in the Local Authority to look at ways of limiting the accessibility of NPS.

I gave evidence, at the Senedd in Cardiff, to the Welsh Government (WG) Health and Social Care Committee, and attended the launch of the WG Report which gave 14 recommendations, regarding tackling the issues of NPS. These recommendations were focussed around providing better awareness through Education and which also called on Central Government to introduce legislation to ban all New Psychoactive Active Substances as soon as possible.

I was delighted to hear the Queen's speech setting out Central Government's intention to ban all Psychoactive Substances in line with proposals which we as a Council had submitted in our Notice of Motion.

On a more local level, I met with countless local residents, families and Traders regarding the impact these substances have had on your daily lives.

I am determined that we will continue with our efforts as a Local Authority to introduce better Education and awareness of these products and tackle this issue on our High Streets. We as an Authority have no intention of waiting for legislation to catch up and we will continue to lead the way.
