### 1 **Disclosures of Personal and Prejudicial Interests.**

**4 Public Services Ombudsman for Wales Referral - Alleged Breach of the Code of Conduct by a former Community Councillor.**

The Head of Democratic Services on behalf of the Monitoring Officer presented a report to consider the report of the Public Service Ombudsman for Wales (PSOW) in relation to an alleged breach of the Code of Conduct by a former Community Councillor which had been referred to the Monitoring Officer for determination by the Standards Committee.

The Head of Democratic Services outlined the details of the complaint. The Committee were asked to consider whether there was:

- a. no evidence to support the complaint or
- b. whether the former Councillor concerned be given the opportunity to respond, either orally or in writing.

The Committee considered the evidence and felt that there was sufficient evidence to proceed to the next stage of the process and the former Councillor be given the opportunity to respond. The Committee would consider the arrangements for a Hearings Panel to hear and determine the matter, in accordance with the Hearings Panel Procedure.

- 1) The Head of Democratic Services / Monitoring Officer write to the former Councillor and the PSOW inviting them to respond in accordance with the Hearings Panel Procedure.
