Statutory Licensing Sub Committee Procedure/Running Order

The procedure to be followed by the Committee is as follows:-

1. The Chair will:
 - Open the meeting.
 - Introduce themselves, Members of the Committee, Officers present and ask the other parties to introduce themselves.
 - Explain the nature of the decision to be taken.
 - Ask the Lawyer advising the Committee to outline the procedure to be followed.
2. Members will be asked to make any declaration of interest.
3. The Chair will ask the Licensing Officer to present the report
4. Members of the Committee will be invited to ask any relevant questions of the Licensing Officer.
5. Responsible Authorities and other persons present will be invited to ask for any clarification in respect of the report presented.

Representations – Responsible Authorities

6. The Chair will invite each responsible authority to fully outline the nature of their representation in the following order:
 - South Wales Police.
 - Trading Standards.
 - Mid and West Wales Fire Authority.
 - Health and Safety.
 - Planning Authority.
 - Pollution Division.
 - Child Protection.
 - Primary Care trust/Local Health Board.
 - Licensing Authority.
 - Immigration.
 - Other Persons.

7. The Chair will invite Members of the Committee to ask questions of each responsible authority.
8. The Chair will invite the applicant and other persons present to ask questions of each responsible authority.

9. The Chair will invite each of the other persons present (or their appointed spokesperson where there are a number of other persons and the nature of the representations are similar), to fully outline their representation.
10. The Chair will invite Members of the Committee to ask any relevant questions of the other persons.
11. The Chair will invite the responsible authorities and applicant to ask questions of the other persons.

12. The Chair will invite the applicant and/or the person representing them to fully outline their application.
13. The Chair will invite Members of the Committee to ask questions of the applicant.
14. The Chair will invite each responsible authority and other persons present to ask questions of the applicant.

15. The Chair will give all parties the opportunity to briefly summarise their key points and make any final points of clarification. The order will be:-
 - responsible authorities;
 - interested parties.;
 - applicant.
16. Members will consider if they need to go into private session to receive legal advice and to debate the application.
17. The decision will generally be given, with reasons, together with a summary of the legal advice provided within 5 working days of this date.

- 9.3 In reaching the decision the Committee must, having regard to the representations, take such steps mentioned below (if any) as it considers appropriate for the promotion of the licensing objectives: -
- (a) Grant the licence subject to:
 - i) conditions that reflect the operating schedule, modified to such extent as the authority considers appropriate for promotion of the licensing objectives. Certain regulated entertainment under the Licensing Act 2003 (as amended), has been deregulated. Where entertainment is deregulated but licensable activities continue to take place on any premises, any licence conditions imposed on a grant of a licence in respect of any deregulated entertainment will be suspended.
 - (b) Reject the whole or part of the application.

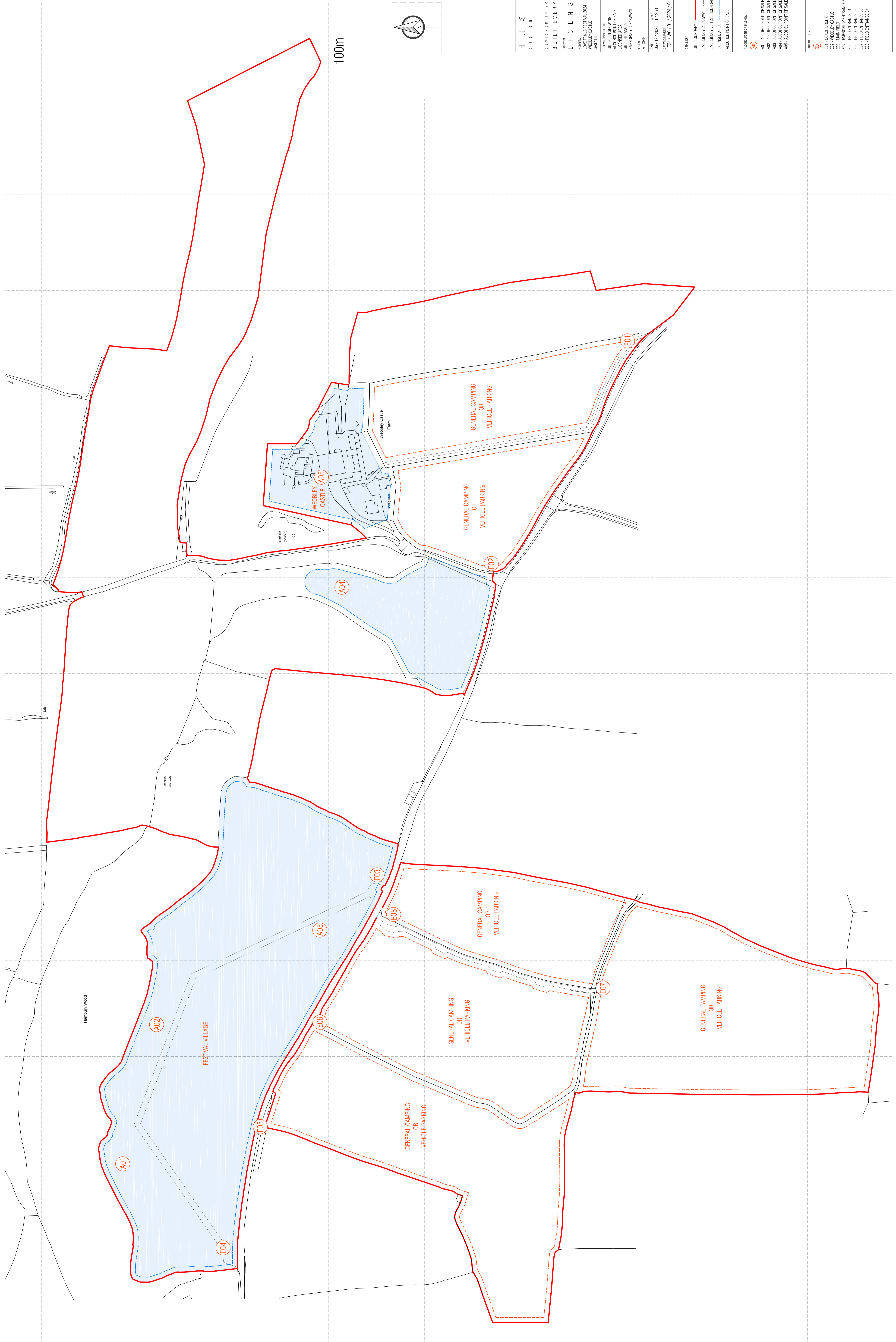

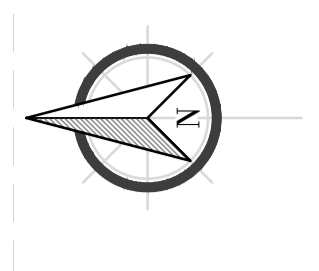

Annex 1 – Mandatory conditions

1. No supply of alcohol may be made under the Premises Licence -

(a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or

(b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.

2. Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.

3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.

a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol



over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-

- (a) a holographic mark or
- (b) an ultraviolet feature.

6. The responsible person must ensure that -

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Where the Premises Licence allows Exhibition of Films

1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.

2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.

3. Where

(a) The film classification body is not specified in the licence, or

(b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4. In this section "children" means any person aged under 18; and "film classification body" means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984(c39) (authority to determine suitability of video works for classification).

If the Premises Licence has conditions in respect of Door Supervision (except theatres, cinemas, bingo halls and casinos)

1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:

(a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or

(b) be entitled to carry out that activity by virtue of section 4 of the Act.

2. but nothing in subsection (1) requires such a condition to be imposed:

(a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c12) (premises with premises licences authorising plays or films); or

(b) in respect of premises in relation to:

(i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

(ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).

3. For the purposes of this section:

(a) "security activity" means an activity to which paragraph 2(1) (a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act, (see Section 3(2) of that Act) and

(b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Minimum Drinks Pricing

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1 -

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b) "permitted price" is the price found by applying the formula -
 $P = D + (D \times V)$

Where -

(i) P is the permitted price

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) The holder of the premises licence

(ii) The designated premises supervisor (if any) in respect of such a licence, or

(iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.



4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.



Annex 2 – Conditions consistent with the Operating Schedule

1. There shall be a personal license holder on duty on the premises at all times when the premises are authorised to sell alcohol.
2. No drinks shall be served in glass containers at any time.
3. No glass bottles are allowed on the premises by attendees, at any time.
4. The number of SIA licenced door supervisors will be subject to the Risk Assessment and is outlined in the Event Management Plan. A final security plan will be available 31 days prior to the event and pre-negotiated with the responsible authorities of Swansea Council.
5. A detailed bound numerical register of door supervisors to be maintained at all times at the premises. Such a register to include the name, registration number, contact details of the member of door staff along with the date, time on duty and time off duty. Full details of the agency supplying the staff to be endorsed and the register to be available for inspection on request by an Authorised officer.
6. All staff engaged outside the entrance to the premises, or supervising or controlling queues, shall wear high visibility jackets or vests.
7. An incident recording book, bound in numerical order, shall be maintained at the premises showing details of the date and time of assaults, injuries, accidents, or ejections, as well as details of the members of staff involved, the nature of the incident and the action/outcome. the book must be kept available for inspection by the police and authorised officers of the licencing authority.
8. The consumption of soft or alcoholic drinks is prohibited on the highway outside the premises.
9. All alcohol will be displayed behind the counter and supplied on a counter service provision only.
10. The number of persons permitted in the premises at any one time shall not exceed 4000.
11. A mobile medical team shall be present at the premises at all times the premises is open to the public.



12. Free drinkable water to be available on request of customers where it is reasonably available. The number of water supply outlets will be referenced in the Event Management Plan dependent on how many attendees.

13. Rubbish disposal points to be placed throughout the site including regular sweeps from the litter team.

14. Compost eco toilets will be available to all attendees at a ratio of roughly 1 per 80 females and 1 per 400 males as per industry standard.

15. Substantial food and non-intoxicating beverages, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.

16. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.

17. A direct telephone number for the manager of the premises shall be publicly available at all times the premises is open. The telephone number is to be made available to residents in the vicinity.

18. Specific children's festival tickets are on sale for those under the age of 18 and these ticket holders will receive a different festival wristband to general ticket holders.

19. A challenge 21 proof of age scheme, shall be operated at the premises where the only acceptable forms of identification shall bear their photograph, date of birth and a holographic mark.

20. Challenge 21 posters will be present at every bar.

21. A detailed refusal log book shall be kept detailing all refused sales of alcohol. The log will be kept on every bar, and shall be available for inspection at the premises by the police or an authorised officer of the council at all times the premises is open.



22. Bar briefings will take place every morning of the event and a signed log will be kept of everyone who attends the briefing.

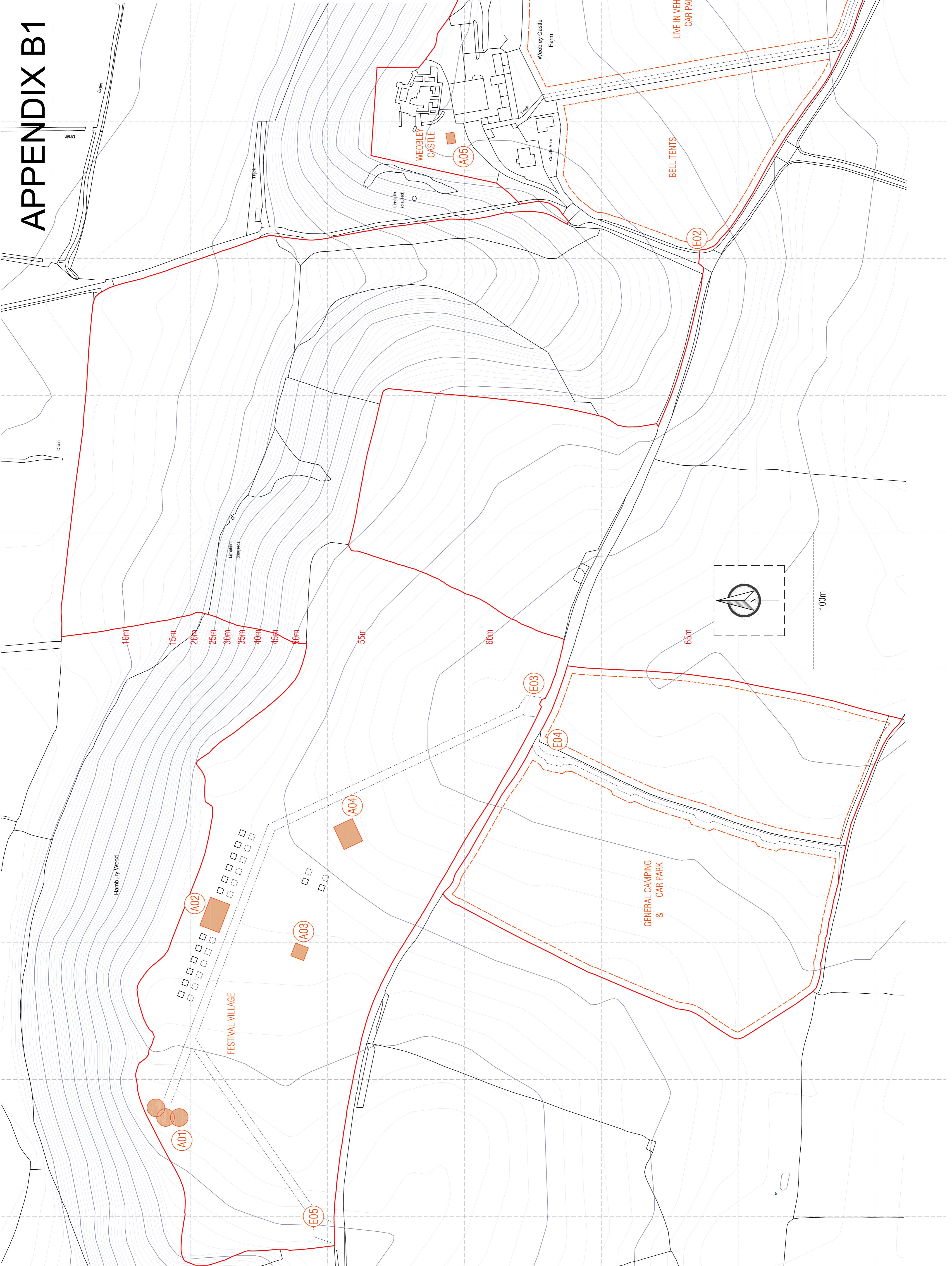

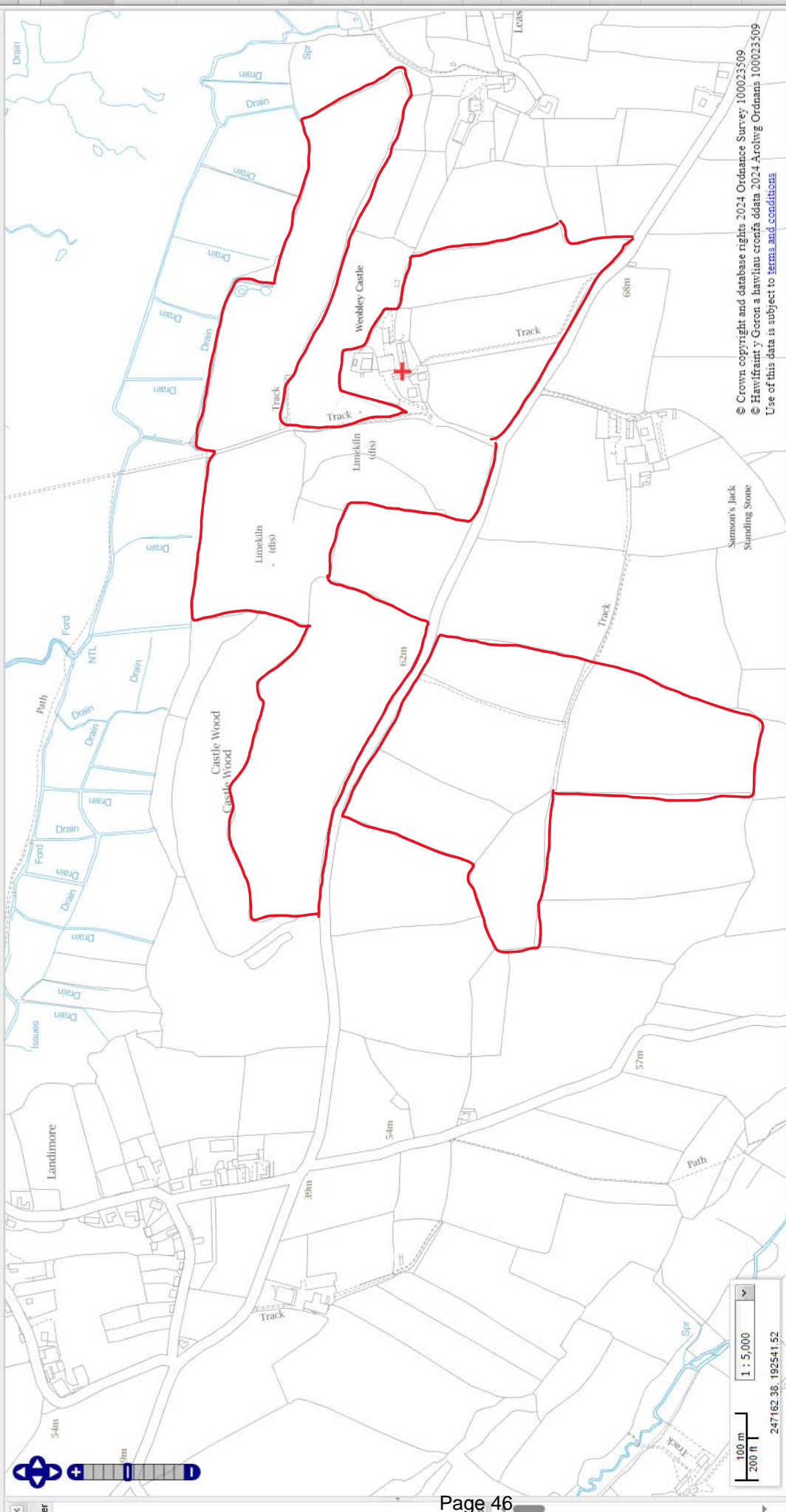

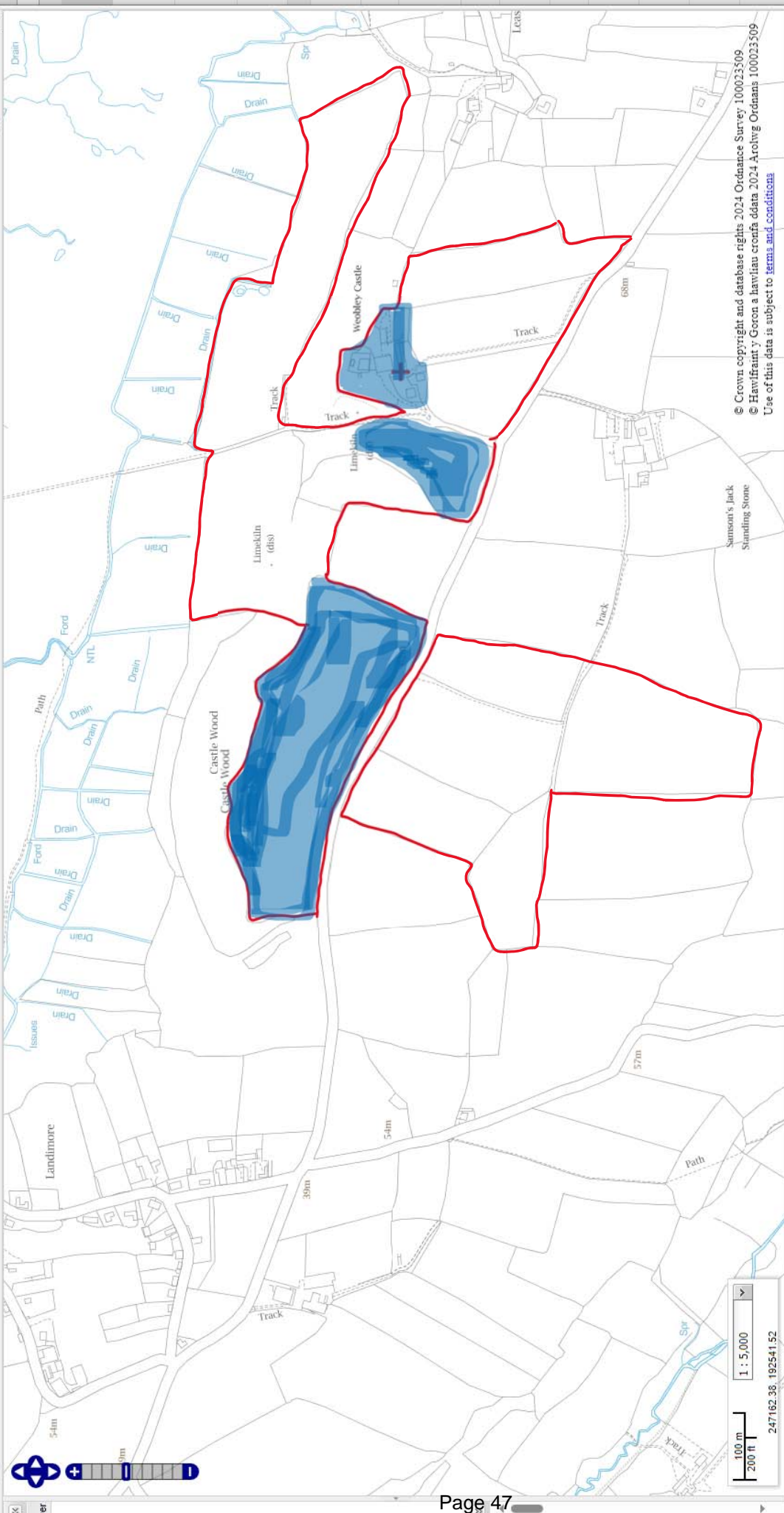

The Noise Management Plan, however, doesn't allay my concerns that live amplified music in the early hours of the morning may cause a nuisance to local residents. Given the very low background noise levels on The Gower (20 – 25dBA) it could be possible that the low frequency content of amplified music will be heard up to 2 miles away. A complaint received in respect of the Love Trails Festival 2023 referred to the fact that they lived over 2 miles away and could hear the bass beat. Many thanks Jen Aazem</p>

We wish to formally object to the application for variation of a premises licence SJ088998. REDACTED</p> <p>1. In relation to Application Requirements</p> <p>a) Residents received a letter from Love Trials, as is suggested in the application, the letter indicated small changes to the current licence, with no mention of music just food and drink, this is clearly not the case with 17 variations applied for, the majority related to licence hours for music and alcohol. in addition, the application says a telephone number for noise complaints will be provided 24 hours this is not indicated on the letter, the letter is misleading with residents not realising the extent and variation that had been applied for and we feel that this amount of variation does not fit with the “small variations” allowed.</p> <p>c) Local residents have not been given a fair opportunity to object to this application as “notices have not been placed every 50 metres on the external perimeter of the premises abutting any highway” consequently more time should be given to residents to discuss any comments or raise objections.</p> <p>c) The variations do not reflect the original purpose of the festival, i.e. trailing with ancillary activities such as food and drinks. The application now favours the Music, dancing and drinking as the primary objective with the “trailing” being the secondary.</p> <p>2. In relation to The prevention of Crime and Disorder:</p> <p>a) The overall licence change in timings (if granted) will extend the selling of alcohol for the whole period of the festival, 1st day 14.5 hours, 2nd day 15.5 hours, 3rd day 16.5 hours, 4th day 14.5 hours, finishing at 03.00 am, on the Monday morning. This festival is primarily meant to be a family event with trailing at its core, Prior to submitting my</p>

objection, I contacted Sarah Prichard at Love Trials, she assured me that residents will hear nothing from the festival at all and that details of the mitigation in respect of all four licensing objectives will be in its Event management noise plan in addition she states that **“The core offering at Love Trails Festival is always trail running, adventure & wellbeing activities”** The links between alcohol consumption and crime and disorder are well documented, there can be little doubt that by allowing the increased consumption this application will fail to achieve the desired objective of preventing crime and disorder. these licencing hours will encourage excessive drinking and the well-known side effects of this can breed disorderly conduct and or criminal activity.

b) The site opening hours say the site will close at 12 noon on that Monday after serving alcohol until 03.00 am. This will present the opportunity for some attendees to break the law by driving out of the festival when they may still be under the influence of alcohol or at the least not have had sufficient time to have the alcohol leave their system ensuring they are not a danger to the public and residents alike.

In relation to Public Safety:

- a) Not all visitors stay on site, many stay elsewhere and need to make egress from the site, the safety of public pedestrians local residents and also the attendees could be compromised with numbers leaving under the influence of alcohol walking narrow lanes, with no street lighting, at clocks in the morning, the site is vast and there is movement between areas the people on the public roads getting back to the accommodation areas will present a more acute public safety issue with revellers going to bed, meeting residents going to work!
- b) The current licence is until 11 am on the night prior to close, offers a safe and sufficient time giving over the recommended 12 hours before operating any machinery or driving when leaving the site during or at the end of the festival, there is no justification for a 03;00 am licence.
- c) The current licence offers a 2 am alcohol licence which is longer than any other event venue is permitted in the area, to comply with and adhere to the licencing requirements, hence all event spaces should be subject to the same stipulation including love trials.

In relation to prevention of Public Nuisance

- a) The requested timings for Live/Recorded Music to be extended on all days of the festive Thursday to 1 am, Friday to 3.00 am, Saturday to 4.00 am and Sunday to 2.30 am (to fit with the alcohol licence times and food service times) and the addition to the licence for dancing to be permitted for the same timings will prove a public and residential noise/light nuisance. There can be little argument that the increased consumption of alcohol and addition of live music and dancing will considerably increase the noise nuisance currently experienced. The later licence times will increase the level of noise into the following day 3 am and 4 am is not a reasonable time request and is more suited to nightclubs in city centres than a rural area. Similarly, the addition of food service for the same times, with generators running being used to provide cooking and light pollution increasing the likely hood of later and later retiring times for revellers, again suited more to city centre night areas not rural areas. The changes will have an impact of probable higher footfall to the festival of those not involved in the “core” principle activity currently of trailing inevitably causing increased noise with increase numbers, changing the whole intended purpose of this event. The Event management plan mentioned in the

application is not available and as such determination cannot be made as to whether it will mitigate any increased noise.

- b) The road changes implemented impact daily business increasing journey times for residents and visitors not attending the festival, impacting businesses providing services to the community and visitors, the extended times will increase the volume of attendees increasing the road use and further impacting local businesses, resident, and visitor alike.
- c) There is a specific issue relating to all and any festival held at Weobley Castel and surrounding areas. The Water system is antiquated and whilst local residents including ourselves have replaced all of our own onsite water pipes, the main system is not equipped to deal with higher volumes of use and the water board have made clear they will not be making any investment of infrastructure in this area, the result is during busy visitor times, we have issue with our water supplies, causing low pressure and sometimes the inability to use our own services, and having little drinking water readily available. Currently the issue is just about manageable with local installing wells for dirty water supplies, however we are not able to have our own drinking supply we are reliant on the mains water supply which is severely depleted during these events. The application changes will encourage increased activity with different aims at the festival, increasing the demand on the drinking water and impacting residents, without a plan to resolve this fundamental issue this will cause a permanent public nuisance problem to the area.
- d) **Comments:** The current licence times for music recorded or otherwise causes some disruption to residents, some having to refund holiday guests because of the noise, road disruption and behaviour of some of the visitors to the festival, impacting and preventing them carrying out their business during the festival, having to compromise and not rent or rent at lower rates to compensate for the disruption. Whilst this is not ideal over the last years that the festival has run, most businesses have managed this issue themselves and have understood that this festival is ongoing and continue to manage it to the best of their ability without making difficulties for those who wish to host these events and the visitors who wish to partake. That said there must be a balance and this application does not show that balance, it is the thin edge of a very thick wedge and if granted will enable Love Trails Ltd or should I say The Event organiser at Love Trials (which means this could be any Event not just love trials in the future) the opportunity to bring large more disruptive events to a small area without the infrastructure to carry anything of any larger magnitude. Many types of events take place at Weobley Castle and local residents including ourselves support them, we wish to encourage visitors to the area to help sustain the local economy enabling our villages to survive, we will continue to support the love trails in its current form based on its principles when it started of a trailing event with ancillary music etc, this application for changes does not reflect that initial goal and we will not support the changes that have been proposed as they are not deemed reasonable and do not fit with the Department for media culture and Sport aims of “improving the quality of life for all through cultural and sporting activities, support the pursuit of excellence and champion the tourism creative and leisure industries” We can also state categorically that noise can and will be heard by local residents, this is proven in the past and Love Trials representative need to stop purporting that this isn’t the case, they have submitted this application early for the very reason they know that there will be issues around noise and the late licence application and with that in mind seek to completely change the appearance of the festival in its current form/

The necessity for extended alcohol, music and dancing should not be a priority, it does not fit within the Love Trails core offering and will cause public nuisance, disruption and potential crime and disorder. The festival welcomes families with children and intends to provide a child safety policy within its event management Plan alongside the noise prevention plan, which it will not submit until 3 months prior to the event? How is it possible to properly assess/grant this application without all the details required to make sure that public nuisance, child safety, prevention of crime and disorder can be safely mitigated.

Police Representations to the application for a Notice of variation of a Premises Licence under Section 34 of the Licensing Act 2003
Premises: Love Trails Festival Ltd, Weobley Castle, SA3 1HB.

On behalf of South Wales Police, Swansea, Neath, Port Talbot Division I wish to make the following representations based upon the licensing objectives.
Crime and Disorder
An event of up to 5,000 persons on four consecutive days in the rural location of Gower will result in a large amount of people coming into the area which comes with concerns. This has an effect not only at the event but also in the general vicinity and surrounding area. Event attendees will not only look at staying at the event but will also use campsites close by.

The Gower is a rural location and historically have many thefts during the spring and summers months leaving many victims of crime. Due to the location, there is limited police coverage with only a small number of local police officers. Due to the numbers attending it is inevitable that the crime levels will rise and although provisions will have been put in place by the event organisers there are concerns that this will continue to rise if the event is allowed to run until 4am. There will be long periods of drinking alcohol which inevitably will result in disorderly conduct. The variation proposed time of continuing from 2.30am to 4am is concerning which would also put a strain on police resources as they would have to be utilised from other sectors to assist which in turn would leave surrounding neighbourhoods vulnerable. The event proposed dates could also potentially clash with the Air Show and any other events that happen around this time which again would draw on resources.

Public Safety

This level of event has concerns for South Wales Police due to high numbers of visitors who will be intoxicated throughout the event. Due to its rural location, should attendees carry on drinking as proposed in the variation as alcohol timings are later than live music there are concerns, person could wander off in their intoxicated state have a medical episode as is seen on most weekends on Wind Street and not be found for a considerable time.

Public Nuisance

The area proposed for the event is frequented by holiday makers due to the location, which during the summer months as mentioned previously is a crime hotspot due to thefts from tents, caravans and campers in general, which requires dedicated police patrols. This event would invariably attract more people into the area and consequently add to the problem of anti-social behaviour returning to campsites or indeed leaving which would also cause problems for noise pollution.

Protection of Children from Harm

Again, there are concerns that continued drinking until 4am can lead to indecent and serious assaults as is seen on Wind Street after 2am. There would potentially be issues with underage drinking with no supervision. Should this variation be granted there would need to be a robust Event Safety management Plan with consideration to Special Police Services, extensive SIA and medical provision.

To conclude, I accept that each Variation Application is on its own merits however the objection reasons as highlighted above are to maintain a safe event at all costs.

Due to the rural location and no such dedicated policing for this event that Wind Street has for After Dark it raised concerns for the safety of the public.

South Wales police submit that this is a reasonable and proportionate response to oppose this Variation Application and the above information is submitted for your information and consideration.

However, over the last two years the noise from the amplified music was way too loud and far too long into the night. We live a 1/2 mile along the estuary from the site and the noise level was really high, particularly a continuous very loud bass! I'm surprised given the setting, and the surrounding villages that the license could possibly be further extended so late. We see little requirement for a running an outdoor even to morph into a late-night rave/festival. I will again be contacting the organisers to express my concerns about the timings, at this stage I would like to know if these late times are permissible in the event license issued by Swansea Council.

I am aware that environmental factors can influence how the music is carried, and SW wind (the prevailing wind on Gower) makes the noise pollution even worse in Llanrhidian. We are aware that the festival is trying to mitigate any disturbance by offering free tickets and agreeing to provide a telephone dedicated telephone number closer to the date for neighbours to call with any concerns. But realistically given the demographic of the neighbouring villages this will be of little use as a mitigation.

I wish to strongly oppose the above application for the reasons given below.

The ' Guidance for Interested Parties' provided by the Council states that 'Our aim is to improve the quality of life for **all** through cultural & sporting activities, support the pursuit of excellence & champion tourism, creative & leisure industries '. In this regard, granting this application to extend the hours at the event for all the stated activities will further diminish the quality of life for local residents in the communities neighbouring the event. In particular I refer to the proposed extended hours for live & recorded music on Thursday from 16.00--1.00, Friday 9.00-3.00, Saturday 9.00-4.00 & Sunday 9.00-2.00 & alcohol on Thursday 12.00-2.30, Friday 12.00-3.30, Saturday 12.00-4.30 & Sunday 12.00-2.30. The additional hours will further exacerbate the noise & general disturbance caused to residents both during daylight hours & into the early morning. Residents will have their sleep compromised for 4 consecutive nights & will suffer increased light pollution caused by lighting at the

event.

I am a resident of Landimore, which is less than 400metres from the site. The activities will have an unreasonable & detrimental impact on the village by virtue of the noise & disturbance referred to above & in addition the distress caused to local livestock & serious disruption to local traffic. The roads are narrow country lanes, some of which are single track & which are currently seriously pot holed. These are concerns of public safety.

When addressing the protection of children, I question whether the late hours applied for can be viewed as promoting that objective. Both the children of residents & those attending the festival will be detrimentally impacted by virtue of disturbed sleep.

In a letter sent to residents in late December 2023, Love Trails state that they are working with the Council to ensure the event's impact is managed & reduced. This application will have an increased negative impact on all neighbouring communities by virtue of the duration of the public nuisance caused by the noise & disturbance. Love Trails also states " we want to assure you that we will take every measure possible to manage & reduce the noise." In my view, this application wholly undermines that declared intention.

As other events at Weobley are staged in the summer it would be appreciated if the Licensing Committee could prevent these events from falling on consecutive weekends.

Good afternoon,

I wish to give you my thoughts on the application in connection with the Notice of Variation of Premises Licence under S.34 of the Licensing Act 2003, for the above event.

The Love Trails Event started some years ago on a site opposite to where it is currently held.

It was attended by a few hundred people with the laudable ethos of promoting walking, running, swimming and at night, dancing.

It has now grown to an event hosting nearly 5,000 people with the emphasis much more aimed at drinking and dancing until (under the present Licence) up to 2:00am.

I live in Landimore some 3-400m from the site of the event.

In the past few years, we have experienced noise levels which make it difficult to sleep until the music stops playing.

I therefore **strongly object** to all the proposed time extensions, on the grounds of Public Nuisance.

The Nuisance caused by the level of noise from the Live and recorded Music (and attended dancing) is obvious, however, what is less obvious is that whilst food and alcohol are being served the site doesn't "settle down", and the noise levels continue at an unacceptable and disturbing level.

I would also comment that I would also object to these hours of serving on the grounds of both Public Safety and even Protection of Children from Harm.

Why?

Because on two days (Thursday and Sunday) local people will be kept awake until the early hours and then the next day will have to travel to work/transport children to school.

Also it is noticeable that it is proposed that Alcohol be served until 2:30am Monday morning and the site is vacated by 12:00 Monday, meaning everyone has to get in their vehicles and leave the site!!!!

A potential Public Safety issue.

I would also like to comment on the process behind this application.

I have no objection to the Love Trails Weekend taking place under the same licensing terms as last year but I feel that the extension of hours they have applied for is unreasonable and will have a major impact on the adjacent properties and nearby homes and villages. On a clear day/night the noise levels can carry for several miles. I feel that granting this extension will be a public nuisance as many people locally have to run businesses and go to work.
