As Sketty Councillors, we attended 21 surgeries over the year (twice every month, except August and December) and were present at most monthly Markets at Bishop Gore School.

I have responded to about 60 communications from constituents dealing with a range of issues from potholes, planning issues and housing, to assistance with benefits and access to finance for those in need.
