## **Section 1: Constituency activities**

I attended ward surgeries most Saturdays: between the four members for Castle we shared this responsibility so that at least two of us attended each week. We also shared attendance at PACT and residents' meetings. I was on St. Phillips Community Centre management committee and attended monthly meetings there. I was active in the emerging "Friends-of-Brynydon-Park group", where I attended meetings and helped to organise events at the park. Constituents were able to contact me directly via phone and email. I often dealt with routine ward issues such as pavements, dog mess, lighting, parking and rubbish, from walks around the area.

### Section 3: Councillor's role and responsibilities

I was a member of the School Performance Scrutiny Panel, taking a particular interest in education matters. Out of this panel and the Estyn inspection, a need to scrutinise provision for education other than at school became clear, and I was part of the group pursuing this. I attended Community Cohesion Action Group when possible, as there were obvious links with equalities work. I linked with Councillor Mitch Theaker with regard to his lead on the hate crime element of the CoCo Action Plan. I sat on the Healthy Nightlife working group, as the Castle area featured significantly in the work plan. I attended Licensing Committee meetings when I felt the need to challenge certain applications within my ward. I was on the Welsh Books Council and attended meetings twice a year in Aberystwyth. I attended Communities First South cluster meetings, and took an interest in how they were meeting their targets and supporting communities. I was a governor at Ysgol Crug Glas Special School and Waun Wen Primary School, and sat on their various sub-committees.

I was active on the development of the Friends-of-Brynydon-Park Group, working with residents, Police Community Support Officers (PCSO's), Communities First and local groups (residents and Maesglas centre) to grow a strong group of committed people working to improve and extend the use of the park. This included taking a key role – alongside residents - in organising family days, an opening event and litter picks.
