#### **Section 1: Constituency activities**

I attended ward surgeries regularly. Castle councillors met weekly at different venues across the ward, and my colleagues and I arranged attendance between us.

Constituents also contacted me via telephone and email and I dealt with matters such as housing, planning, litter, lighting, sand and other environmental issues, as well as signposting to partners for things like anti-social behaviour. I attended residents / neighbourhood / Police and Communities Together (PACT) meetings in Sandfields, Brynmelyn, Marina and Mount Pleasant, and linked with Police Community Support Officers (PCSO's) regularly.

I was and still am on the committee for St. Phillips community centre and attended regular meetings. I met with project leads on Sandfields Neighbourhood Renewal Area to check the progress of the housing upgrade programme and District Housing Officers to get updates as to the situation for council tenants in the ward, empty properties, rent arrears etc. I also contributed to planning applications, representing constituents in appeals against applications.

### Section 3: Councillors role and responsibilities

I was convenor for the Schools Performance Scrutiny Panel, a permanent panel which dealt with the majority of education related scrutiny work. This met at least monthly and looked at broad issues affecting schools as well as individual school case studies, across primary and secondary sectors. I represented education on the Local Service Board Scrutiny panel, and reported quarterly to the Scrutiny Programme Committee on the workplan. A further, associated line of inquiry stemmed from this panel, and I became convenor for the School Governance Scrutiny inquiry. I was a governor at Waun Wen primary school and Ysgol Crug Glas, attending meetings regularly and sat on sub committees dealing with disciplinary issues. I attended Communities First meetings to monitor progress in this work programme. I represented the council on the Welsh Books Council, attending meetings twice a year.

### **Section 4: Initiatives and Special activities**

I was active in the development of Friends of Brynydon Park group, sitting on the committee and contributing to events in the park including linking with a local school and Natural Resources Wales for a stargazing event to showcase our star path, as well as foraging in the park and family fun days. I sat on the Purple Flag committee working towards the application for the quality award, contributing my views as a city centre ward member and assisting in preparation, linking with safer Swansea and South Wales Police to carry out a trial assessment of the nightlife, looking at safety and the range of entertainment offered by the city centre.

Our scrutiny meetings always bear in mind the corporate priorities and consider how they fit in with these, with improving pupil attainment and safeguarding vulnerable people being particularly relevant to our work, as well as tackling poverty.
