Section 1: Constituency activities

I have attended regular public PACT meetings held in St James' Church Hall and Brynmill Community Centre with fellow community leaders such as police officers. I have facilitated the following road traffic orders after consultation with constituents:

- a. Double yellow lines on the corners Glanmor Park Road to improve vision when emerging onto Sketty Road.
- b. Reconfiguring the bus bays outside YGG Brynymor to allow parking outside school hours and also provide a 10 minute drop of zone for parents.
- Extending the zig zags on the Sketty Road zebra crossing to lessen the chance of accidents from cars emerging from Hawthorne Avenue due to obstructed vision.
- d. Double yellow lines on the corners of Lon Bryngwyn, Lon Cwmgwyn and Lon Cadog to improve vision when emerging onto Townhill Road.
- e. Yellow line protection to prevent obstructions on the lane running between Canterbury Road and Brecon Place.

In the summer, I facilitated a scheme to provide hanging baskets in the Brynmill area. Constituents contacted me be phone, email and letter. They also met me in my home or theirs if they wished to have a face to face meeting.

I facilitated a properly marked bus stop in Marlborough Road.
