Section 1: Constituency activities

I attended a significant number of representative meetings, both formal and informal, with constituents, council officers and the many residents groups in the ward as well as local businesses. I have met with police and PCSOs (Police Community Support Officers) to discuss issues around licensing activity, substance misuse and anti-social behaviour and attended various PACT meetings. Together with colleagues I attend our Saturday morning councillor surgeries across the ward in Marina, Sandfields, Brynmelin and Dyfatty. Additionally I attended various Residents and PACT (Police and Communities Together) meetings across the ward, plus other community meetings, including District Housing & the Sandfields Renewal Area. I also attended meetings of Community First cluster groups.

I responded and dealt with a significant number of electorate issues and complaints, by phone email, on-site or home visits. These continue to mainly relate to, Street Scene, (litter, dog mess, waste collections, footpaths and parking), anti-social behaviour and alcohol and drug related problems, housing issues (both allocation and condition). I have also had a more direct representative role in some Social Services/Education issues and tenancy agreements. I maintain a close interest in ward planning issues and represented resident's concerns at committee.

I regularly visit events & organisations and seek to maintain good relations with the various ethnic communities living in the ward. I act as auditor to various groups, continue to take an interest the Vetch Veg project and the development of Bryn-y-Don Park.

I have also with Cllr Crouch been active in supporting a local bowls club in their efforts to take over their bowling green and park and assisted in their recent successful application for financial and other support.

I continued to support the Friends of Bryn Y Don Park and am pleased that it continues from strength to strength in developing and improving the park for the benefit of local people, which now includes many activities for local residents especially children.

Together with colleagues I continued to argue for more green space in the City Centre and support residents' campaign to retain the Vetch Field as a proper park.

Whilst investment in the City Centre is welcome I continue to be concerned that such development has to take account of its impact on the present and future resident population – that it cannot be development at any price.

Despite its inherent wealth Castle ward also has extreme poverty and deprivation - just a few minutes' walk apart - and I remained committed to ensuring that the Authority responds to the challenges that this presents.
