Section 1: Constituency activities

I kept my residents regularly updated on my activities by delivering three non-political newsletters to all homes in Penllergaer (4 pages of A4 issued in April 2014, Sept 2014, Nov 2014 and March 2015). One of the most significant concerns I continued to be heavily involved with was the Local Development Plan (LDP) and the potential impact of 850 or more new homes in our community. I therefore held another well-attended meeting in January 2015 to update residents on the LDP process and went to many more organised by the Action Committee of which I am a founder member.

I also kept residents informed, via my newsletter, of the progress in obtaining the long awaited upgrade of the playground on Gors Common.
