Section 1: Constituency activities

Since being elected in May 2016, I have held regular surgeries at Treboeth Public Hall and Clase Community Centre, to deal with issues from residents including Highways, Housing, Policing, Anti-Social Behaviour, Pollution and Environmental problems.

I have held a number of public meetings which were very well attended to discuss contentious traffic flow problems within the Ward, leading to a substantial commitment from all 3 Councillors from their community budget, to rectify and solve these traffic issues involved.

Following consultation with residents these schemes have been funded and implemented:-

- * Double Yellow Lines to address dangerous parking on Mount Crescent, and the junction of Ger-Y-Coed
- * Double Yellow Lines to improve junction visibility on Llangyfelach Road
- * Resident Parking Bays installed on Llangyfelach Road
- * Speed Bumps and 20mph speed restriction signage on Quarry Road
- * Speed Bumps and 20mph speed restriction on Heol Gwell
- * New traffic island at junction of Quarry Road and Brynawel Crescent
