Section 1: Constituency activities

I participated in monthly advice surgeries and I attended local PACT meetings and addressed any complaints or queries. I attended meetings and worked as a Governor of both Pontarddulais Comprehensive School and Pontarddulais Primary School. Member and past Mayor of Pontarddulais Town Council I attended monthly meetings. The Town Council provides a range of local services including: the management of the Institute to provide space for community organisations; office space for the police; flower displays; film shows for children; Christmas Parade, decorations, trees and pantomime; financial grants to worthy causes; monthly market; carnival quiz. Constituents contacted me with a range of issues and provided advice, support and practical help. I delivered a newsletter to constituents based on issues of interest and local information. I informed Council Officers of issues that were raised by and caused concern to constituents such as traffic light sequencing; traffic light layout; excessive traffic speed; kerb heights; lack of parking notices; fly-tipping; height and spread of trees on the highway and close to housing given the deterioration of weather conditions; parking on pavements.

Negotiated pavement redevelopment. Provided support through the petition process and advocated and negotiated the wishes of the population of Pontarddulais where there is evidence of concern, a potential for the development of services and an improved lifestyle and a need to support potential developments for the benefit of the community. Worked to develop sustainable partnership approaches across community groups (Friends of Coed Bach Park and the Pontarddulais Partnership) and the council to improve drainage in Second Woods, recycle equipment required such as waste bins and capital improvements such as the tennis courts. Worked with the council to identify and access additional funds to increase resources available for the town enhancements. Worked on rights of way.

Section 6: Other activities and issues

I chaired the Pontarddulais Regeneration Partnership that works with constituents in Pontarddulais to assess community needs, access grants, support the delivery of developments and ensure sustainability for the work on the: Churchyard and Rights of Way on the Marsh; Multi Use Games Area; Railway Station; Bryniago Housing Site; St Teilo parking site; Tennis Courts; Delivery of the play scheme; Maintenance and continuing development of the training centre Canolfan Y Bont; Bont Bulletin community news leaflet. A charity shop has been set up to support the Pontarddulais Partnership that secured £156,130 funding from 7 grant funders to pay for the range of projects. I chaired the Pontarddulais Age Concern luncheon club that aims to ensure a weekly opportunity to meet socially and access useful information as well as organise community trips and holiday opportunities for adults aged 50+ to support positive lifestyles. The club obtained grants of £5270 from 3 grant funders.
