### **Section 1: Constituency activities**

The Sketty Liberal Democrats ran regular fortnightly surgeries in Sketty Park Community Centre and Sketty Library. We also have a regular presence at the Sketty Farmers' Market on the first Saturday of each month, and the bi-monthly PACT meeting. We supported the redevelopment of the Tennis Courts on De La Beche Road and the refurbishment of Parry's Field with donations from the Councillors' Environmental Allowance.

The main issues I have encountered this year have concerned the bed-room tax, trees that are deemed dangerous, dog nuisance, Anti-Social Behaviour, irresponsible parking and the possibility of redeveloping the former Total garage site on Eversley Road. The Council's job re-grading scheme also raised some significant issues.

Other roles: Champion for Language Issues (including Welsh). There have been no significant language issues this year. However the new Welsh Language Standards are expected to be released shortly. I am continuing to work on the development of some Welsh Language Proficiency Tests, which might be used to assess the Welsh Language skills of Council Staff.

In my previous job, I was Professor of Linguistics at Swansea University. Language is important in many areas of the Council's work, and I try to keep abreast with current issues in this area. I run a small scheme that provides funds for interesting language projects in Swansea. During 2014-2015 I funded a deaf sign language project at Swansea University, and the Latin in the Park project.

I continue to be worried about the way the Council relies on data provided to and analysed by the Fischer Family Trust to make projections about children's attainment levels in school. I'm particularly worried by the fact that this very extensive data set has been taken over by a company called Capita. The analysis – described in one journal article as "voodoo statistics" - seems to be particularly bad at dealing with bilingual children, children with severe learning difficulties, and children from immigrant families. We have a lot of these children in Swansea. Watch this space for further developments.
