Section 1: Constituency activities

With ward colleagues I held monthly surgeries at Uplands Market, ensuring a visibility and presence in the local community. I attended PACT meetings and other meetings with the police, residents and local traders and I have been supportive of the recently established Uplands Traders Association. I organised petitions and worked with residents against the proliferation of Houses of Multiple Occupation (HMO's) in the ward. I supported the concerns of residents opposed to proposals to build houses on Ganges Field. I supported concerns of residents regarding the inclusion of Townhill Campus site in the Local Development Plan (LDP).
