## **Section 1: Constituency activities**

I attended monthly PACT meetings and took up issues raised with officers. I used my Councillors Environmental Improvement budget for residents parking bays, yellow lines and disabled parking bays around the ward and the remainder to supplement traffic management measures associated with the new school including speed calming on St. John's Road.

I campaigned for the new Burlais School and worked with officers on consultation, traffic management and other matters associated with the new school.

I regularly take up issues with officers around cleansing, potholes and poor pavement surfaces as well as failure of council to put in effective measures to remove and enforce against dog fouling.

I arranged improvements to common areas in some blocks of flats in Brondeg Crescent, arranged improvements to car park for council flats in David Street, arranged improvements to garden area at the rear of 81-91 Maesglas Road flats. I had motorcycle gate installed on Gwalia land adjacent to 374 and 382 Pentregethin Road. I worked with the council and other agencies to tidy up the site of the former Libanus Chapel. I arranged for the NEAT Team to tidy up a number of lanes and other areas around the ward including land adjacent to footpath at bottom of Vicarage Lane. I also arranged for a number of environmental and security improvements to the sheltered housing complex in Llwyncethin Road.
