#### 1. Introduction

1.1 The purpose of this paper is to provide an overview of the Award of Funding in relation to WLGA Education Grant 2019-2020 – Funding Support to further enhance music provision in Schools in Wales with a further £1,4000,00.

#### 2. The Grant

2.1 Welsh Government awarded this grant directly and did not require an application from the Council. Allocations have been offered to all Welsh Councils. The offer to this council is £103,690 and covers the period to the 31 March 2020.

2.2 The purpose of the funding is for:

Local authorities to use the funding as they see fit and in accordance with local needs to deliver any one, or a combination of the following options whilst showing that they are using the monies in an innovative and creative way:

- FSM Support
- Ensemble Access
- Instruments
- Access and Inclusion
- Progression and Achievement
- GCSE and A level music support
- Rock and Pop Ensemble
- Master Classes
- Co-operative arrangements
- Monitoring
- 2.3 Due to the short timescales for acceptance imposed by Welsh Government, this report is provided to members for their information.
