As a result, there will be a requirement to appoint into this role on a permanent basis from May 2023. It is **proposed** that the appointment process for a permanent Chief Executive commences in September 2022. This will allow for a recruitment strategy to be established prior to September. This strategy will include consideration of appropriate advertising for the role and whether external consultancy is required to support the process in advance of the post going out to advert. The role will need to be advertised externally in accordance with both the Council's constitution and the legal requirements set out in the Local Authorities (Standing Orders) (Wales) Regulations 2006 which require posts with a remuneration level over £100k per annum to be externally advertised. In the event of an external candidate being offered and appointed to the role this will allow for any notice period to be worked or for the post to be re-advertised if a suitable candidate is not appointed at the selection stage.
